Kinds of personal data held

Main Purposes of keeping personal data

Personal data held is kept for the purposes of processing the registration, making reservation of rooms and handling relevant matters relating to the HKIDEAS 2019.

Outsourcing arrangements

HKDA has commissioned a conference organizer to handle the registration matters of the HKIDEAS 2019. All service providers are bound by contractual duty to keep confidential any data they come into contact with against unauthorized access, use and retention.

Protection measures

HKDA takes appropriate steps to protect the personal data we hold against loss, unauthorized access, use, modification or disclosure.

Retention

HKDA maintains and executes retention policies of records containing personal data to ensure personal data is not kept longer than is necessary for the fulfilment of the purpose for which the data is or is to be used.

Disclosure of personal data

The personal data may be provided to authorized parties involving personnel, agents, advisers, auditors, contractors, sponsors and the service providers of the HKIDEAS 2019 and the Executive Committee of the HKIDEAS for organizing the HKIDEAS 2019, handling registrations and related matters such as arrangement of banquets, local tours or social events, granting of CME/ CPD points for attending the events/ courses, etc.

A fee may be chargeable by HKDA for complying with a data access request, if deemed fit. A Data Protection Log Book is maintained as required under section 27 of the Ordinance.
