Introduction

Papers of Limerick Estate Management incorporating James Nash and Sons, 85 O' Connell Street Limerick. The collection includes property transactions relating to a number of members of the Hayes family who held a number of properties in Limerick notably on O' Curry Street and M. Doyle (a builder) who acquired an interest in some of the same buildings and whose rental interests were also handled by Nash Estate Agents. The collection also included material from the Pery Square Tontine listed as P73 Pery Square Tontine Company. The collection also includes a rental of properties in Limerick City owned or managed by the Nash family.
