Introduction

These papers were found in a skip in Raheen in March 1998. They comprise two volumes of a three volume rent ledger of the Sheehy family of Liskennett, and a bundle of flimsy receipts. The letters are mostly for payment of rates in the 1842 – 1848 period, although there is one receipt for the tithe payment from 1831.

Limerick Archives purchased them from the finder in April 1998, through the mediation of the Limerick Civic Trust for £80.
