Introduction

All the activities of Limerick City Council have financial implications and the management of the City Council's finances is a core function of Limerick City Council. This collection consists of financial records of the City Council dating from the introduction of the Limerick City Management Act 1934 to 2000.

The 1934 Management Act provided for the reform of the finances of the Corporation. The five existing kinds of rates – improvement, general purposes, poor, water and borough-were abolished with the exception of the water rates. Instead a single rate called the municipal rate was levied by the Corporation, and sums raised were used mainly to meet current expenditure (see also L/FR/RB). Additionally the various funds into which the municipal authority's income had been lodged and from which monies had been paid out were also abolished and replaced by one municipal fund. Expenditure on works of a permanent nature, which cannot be met out of grants, is frequently met by borrowing.

Series 1 consists of Annual Financial Statements, Abstracts of Accounts and Auditors Reports, dating 1940-2000. At the close of each financial year a summary of the accounts of the Local Authority is prepared and laid before the authority. The abstract of accounts is then forwarded to the Minister for Local Government and audited by the Local Government Auditor who certifies the abstract and reports on the audit.

Series 2 consists of Estimates of Expenses, dating 1953-1961. The Estimate is prepared by the City Manager showing the amount which is required to operate each service in the local authority for the following financial year. The Estimates are then submitted to the council for their consideration at a special meeting called the estimates meeting at which the city manager must be present. When the Estimate is adopted, the council then determines the resulting rate to be paid the following year.

Series 3 consists of records of loans and mortgages received by Limerick City Council, mainly for capital schemes. The Local Government (No. 2) Act, 1960 established statutory power for a local authority to borrow money. Limerick City Council, like other large local authorities, also obtained money for capital schemes by the creation and issue of stock. Issues of stock were subjected to regulations governing the raising of dividends, the redemption fund, the application of money and other matters. Records date 1937-1973.

Series 4 relates to the administration of Limerick Corporation Bank Account between 1950 and 1963. It includes a lodgement book and a sample of advice notes.

Series 5 relates to Municipal Fund Income Receipts (1969-1972)

Series 6 relates to Limerick City Council expenditure. L/FR/FM/6/5/1 relates to the expense claims of Garda Siochana for attending the removal of expenses. These expenses were paid out of rates in the first instance and then recouped by the exchequer.

Series 7 relates to the payment of salaries and wages to Limerick City Council Employees. These records contain personnel information, and therefore are **restricted access.** L/FR/HR contains additional records relating to City Council employees.

The finance section of Limerick City Council is involved with all sections of the local authority. Therefore this collection is a rich historical source for researchers interested in the development of local authority administration and the financial status of Limerick City Council throughout the twentieth century. Entries are arranged by year, and under columns titled 'purpose (of loan)', 'date of mortgage', 'number in mortgage register', 'lender's register number', 'from whom received (ie from whom borrowed)', 'for what period years', 'rate of interest per cent', 'mode of repayment', 'original amount mortgaged for', 'instalments received to close of last year', principal repaid to close of last year', 'principal outstanding to close of last year' 'instalments received during current year (date, amount)', 'total advances received to end of current year', 'total loans to be accounted for during the year', 'interest accrued during the year', 'repayments made during year (interest, principal, date and paying order number'. Special principal repayments during the year (amount, date and paying order)', total repayments of principal during the year', 'principal outstanding at close of year' and 'remarks'. From 1950, the 'purpose' of loan is arranged by sub-headings such as 'subsided housing', 'general purpose', 'sanitary services', and 'public assistance'. Includes also details of contribution to loan charges payable by Limerick County Council, which was agreed between both Councils consequent to the extension of the Borough Boundary and the Local Government Provisional Order Confirmation Act, 1950.

Details recorded for each loan includes the stock account, revenue (stock charges) account, redemption fund (accumulation) account, redemption fund receipts and payments account (summary), and schedule of investments and stock purchased for cancellation for the half year ended 31 March 1944 (prior to the establishment of redemption fund) until 31 March 1973. Under 'purpose' entries relate to specific schemes Housing Small Dwelling Acquisitions Act-Loans' and 'Corkanree' and the associated loans and expenses. Under 'stock account' the details recorded include original issue, cancelled to end of previous year, balance at beginning of year bought forward, total stock cancelled to end of that period. Under Revenue (Stock Charges) Account details recorded include dividend,

interest on cancelled stock and yearly contributions. Under the redemption fund (accumulation) account details recorded include total accumulated fund at beginning of half year, total receipts and credits from revenue, total accumulated fund at end of half year. Under the fund receipts and payments account (summary) details recorded include balance at beginning of half year, interest on stock cancelled, half yearly contributions, other receipts (with attached schedule), total, cost of stock purchased for cancellation and balance at end of half year.

File consists of Account of Expenses (Miscellaneous), Claims for Travel Expenses receipts, justice certificates authorising cheque, and copy cheque issued to the Guard. File generally includes details of the crime committed by prisoner. Includes expense claims for duties such as 'conveyance of witness Joseph Keane, 26 Catherine Street, Limerick to Cork District Cort as state witness...', 'escort of prisoners before committal to prison...', and 'providing two meals for each prisoner who were arrested on 16/2/1948'.

Details regarding monthly salary are recorded under columns titled gross salary for month, deductions, net amount paid, paying order number and date paid per bank. 'Observations' includes entries such as 'salary increased', 'resigned on the...', 'commenced on the...' From 1955 volumes include additional columns to record 'position on scale' and 'temporary allocation' of officer is recorded and 'superannuation', 'social welfare', 'life assurance', 'others', L/FR/FM/7/4 and L/FR/FM/7/8 records weekly sums (rather than monthly) received by officers.

Entries are arranged chronologically by week, and by department such as 'fire section', 'water and public health departments' and 'cleansing department'. Details recorded for each employee include name, occupation, time worked, rate of pay, allowances (rent etc), amount, deduction for insurance, nett sum payable to employee, pay tick, total cost of Insurance stamps, gross amount to be drawn and observations. The volume also has four other columns titled 'Roads', 'Public Health', 'Housing' and 'all other purposes', and each column has various sub-headings, which allows for the exact category of work completed by the employee to be recorded occasionally. For example Roads has columns titled 'maintenance of roadways', 'flagging and footpaths', 'fence walls and dangerous buildings', 'machinery repairs', and 'sundries'.
