

These papers were part of the estate of Richard Russell J.P. He was a member of the distinguished Russell family- they were an old Protestant family who had resided in the city since the middle Ages. Many Russells served in civic offices and were prominent in the business affairs of the city. The bulk of the papers in this collection deal with the Russell's properties in Limerick City and at Faha and Plassey, County Limerick and especially with the estate at Ballincarriga, Kildimo, County Limerick.

Richard Russell was the son of John Norris Russell one of the Limerick's greatest merchants and industrialist. Richard Russell inherited a vast business empire from his father that included mills, grain stores, ships, and ship yard. Richard purchased extensive property in the city and county and expanded his father's many business interests. He purchased Plassey House and its lands from the Maunsell Family who named the House after their illustrious relative's Clive of India's great victory in the battle of that name. Richard also obtained estates at Faha and Ballinacarriga, the latter he purchased at public auction from the impoverished Earl of Charleville in the 1840s. Richard Russell died in 1871 and after his death the Limerick public named and built the city's first public park – 'The People's Park' in recognition of his contribution to the city. Richard left his land to his only son Richard Norris Russell. Norris as he was known had little interest in the Russell business and remained all his life a 'gentleman farmer'. As a result there are few records relating to Russells' many mills and other enterprises. He became a Justice of the Peace in the 1860s. Richard Norris farmed the family estate at Plassey and Ballinacarriga. Faha passed to another branch of the Russell family but eventually returned to the ownership of Richard Norris. Richard and his son were both 'improving' landlords and it was claimed in 1919 that they never evicted any of their tenants in Ballinacarriga in all the time the estate was in their hands. Sometime after 1900, Richard Norris concentrated mainly upon his farm at Ballinacarriga. Richard Russell died in 1919, he never married and his estate passed to his surviving sister and two nieces. The estate at Ballinacarriga was the scene of much controversy after his death, when the descendants of tenants evicted prior to the Russell's purchase of the lands, agitated for portions of the property. This led to a public meeting in Kildimo and an attempt to organise a 'boycott' of the estate of the deceased Richard Norris Russell.

The Russell Papers are of particular importance for several reasons. They offer a unique insight into the Russell's of Limerick. There are many legal documents referring to the Russell's family properties, including deeds, mortgages and marriage settlements. These reveal much of the history of this illustrious family from the late eighteenth century until the 1920s, regarding their personal affairs, marriages, children and property. These documents also reveal much about the affairs of some other notable Limerick families or landowners such as the Maunsells, the Earl of Charleville and others. The papers of Richard Norris Russell afford an opportunity to study the workings of an estate in the early decades of the Twentieth Century. There are records relating to the employment of farm labourers, receipts and Rental Books that allow us a glimpse into the life of a 'gentleman farmer' and his estate.
