



TERMS OF USE

1. Content

The following GTU or General Conditions of Use legally frame the use of the services of the site www.millesime-bio.com (hereafter referred to as "the site").

Constituting the contract between the user the interprofessional association SudVinBio, the user, access to the site must be preceded by the approval of these GTU. Access to this platform means the agreement of the present GTU.

2. Legal mentions

3 Access to the site.

The site www.millesime-bio.com allows free access to the following services:

- Make appointments with exhibitors
- Exchange with the exhibitors

The site is accessible free of charge from anywhere by any user with Internet access. All costs necessary to access the services (computer equipment, Internet connection, etc.) are at the user's expense.

The access to the services dedicated to the visitors is made with a login and a password. For maintenance or other reasons, access to the site may be interrupted or suspended by the publisher without notice or justification.

By registering on the site, the user agrees to receive appointments from exhibitors. Users can manage the receipt of appointments from their account to activate/deactivate this function.

Each exhibitor has the right to request access, rectification or withdrawal of any image or video representing him or her, in accordance with the provisions of the French Data Protection Act (Loi Informatique et Libertés) and the RGPD.
