### **Overview:**

Blackpool Council has commissioned the National Youth Agency (NYA) and Youth Focus North West (YFNW) to undertake a review of the youth sector provision across Blackpool.

For the purpose of this work, youth provision is defined as informal education provision for children and young people from 7 to 25 years old [including]:

 Existing non-statutory services for young people, including youth clubs, sports clubs and uniformed groups

As a part of this review the council have requested:

- 1. A survey of youth sector providers within the Council area.
- 2. Support for a smaller number of organisations to complete a self-assessed review of their service.

Details are not made publicly available, and once the survey and reviews have commenced they will be deleted.

During the survey, we will ask specifically if you'd like to opt-in to inclusion on a national database of youth sector providers that NYA are building, and which will allow you, at that point, to indicate if you would like anything to be made publicly available.

#### **HOW WILL MY PERSONAL DATA BE PROTECTED?**

Appropriate safeguards are in place at NYA for secure collection, storage, transmission and disposal of your personal data in accordance with the General Data Protection Regulation. Access to data is restricted to those requiring access for the purpose of delivering the survey and the data is stored on a secure server. It will be deleted 28 days after the survey period commences.

## **HOW TO WITHDRAW YOUR DATA**

If neither the survey or review have commenced we will remove any personal data which directly or indirectly identifies you within 7 days of that point.

If either the survey or review has commenced you can withdraw your inclusion from that at any time; and we will remove any personal data which directly or indirectly identifies you within 28 days of that point.
