***NEW* COVID-19 safety information films**

More than a month on from the onset of COVID-19 in the UK, Step Change in Safety and OGUK have produced 6 new short information films for the UK oil and gas industry workforce to bring them up to date about the strategy for addressing the virus offshore and at heliports.

OGUK HSE Director Trevor Stapleton outlines the 4 key components of the strategy:

- (1) 'Preventing and Protecting' strategy, which includes testing and health checks.
- (2) Offshore Helicopter travel and the current discussion around face coverings, social distancing in heliports, and temperature checks.
- (3) Installation-specific health and safety, including 'essential work,' personal hygiene, cabin-sharing and social distancing.
- (4) Current procedures for arriving back at UK heliports, 'safe havens' and 'safe passage.'
(NOTE: All information correct at time of recording 20/04/2020)

Step Change in Safety Executive Director Steve Rae looks back at an unprecedented time for the UK oil and gas industry:

- (1) A retrospective view of "the journey" we've all been on since COVID-19 took its grip on the UK; the workforce's role in effective Control of Work and Management of Change.
- (2) The way forward - commitment, the use of social media, family concerns and the need to ask the 'right questions.'

COVID-19 CURRENT PRACTICE: Steps to reduce the risk of Coronavirus transmission.

Step Change in Safety has collated and published current practices being undertaken by some of its member companies to lessen the risk of Coronavirus transmission in:

- (1) heliports
- (2) on helicopters
- (3) on-board installations.

Current practice to lessen transmission risk – Onboard Installations

NB - Information current at time of issue on 16/04/20

Ref.	Measure Description	Status
	Accommodation	
1	Welfare facilities – reduction of recreational seating to achieve increased distancing, define max number for cinema etc, rec rooms could double-up as large meeting rooms	
2	Reduce the number of chairs available in communal areas, ensuring adequate distance is in place between the remaining chairs	
3	Tea Shacks – reduced seating with marked up increased distancing and staggered break times	
4	Mess – communal condiments, jars, dishes, cartons etc - replaced by individual sauce, sugar, salt & pepper sachets, milk tubes	
5	Mobilise additional catering crew for frequent sanitisation of the accommodation door handles, handrails, communal toilets and similar touch-points etc.	
6	Staggered meal-times to decrease numbers sharing a table	
6	Food handlers to serve food rather than individuals using buffet style 'help yourself'	
7	Additional sanitiser available for use around site	
8	Cutlery pre-wrapped in napkins and laid on tables or issued by catering team	
9	Display tape on the floor to encourage increased distance between people whilst queuing to be served	
10	Nominated person should ensure each individual uses hand sanitiser before/at entry to galley	
11	Display signs to encourage people to wash hands before and after eating	
12	Mobile phone/electronic device usage will not be allowed in galley during meal service	
14	Single occupancy cabins per shift, no same shift sharing, rooms sanitised after normal cleaning, room serviced each shift	
15	Avoid critical roles sharing the same cabin where possible	
16	Identify isolation cabins / areas

Current practice to lessen transmission risk - Helicopter

NB - Information current at time of issue on 16/04/20

Ref.	Measure Description	Status
1	All ear defenders sanitised between all flights	
2	All passenger lifejackets sanitised between uses	
3	Aircraft deep cleaned every evening with further sanitisation taking place between every flight	
4	Consideration for IOGP guidance that only disposable earplug used as lessens the risks of virus spread between flights using ear defenders.	
5	Helicopter operator recommendations on social distancing on all aircraft types up to the point of face covering being issued.

Current practice to lessen transmission risk - Heliport

NB - Information current at time of issue on 16/04/20

Ref.	Measure Description	Status
1	Heliport staff are subject to daily temperature screening upon arrival for work	
2	Flight departure times arranged to reduce the number of passengers in heliport at the same time	
3	Signage to encourage social distancing practices	
4	Ground markings to encourage social distancing at check-in	
5	Increased cleaning and sanitisation regimes in place	
6	Tannoy announcements reminding passengers of social distancing guidance	
7	Personal security searches will continue with use of wands where available Security checks to be confirmed with CAA	
8	Security personnel will use hand sanitiser between searches	
9	Passengers to stand with back to security officer during body searches	
10	Security and Check-in staff to wear disposable gloves when checking Vantage cards	
11	Notice board dedicated COVID-19 information available for passengers	
12	Single-use, disposable cups etc to be used in passenger canteen	
13	Social Distancing during safety brief where practicable	
14	Check-in staff to be separated from passengers by screen or face shield

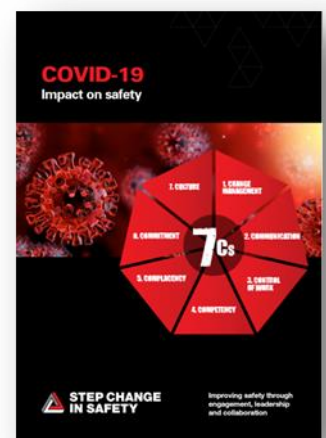
