

Safety Moment - Under Pressure

Based on an incident where 2 people were seriously injured when a 3.4l nitrogen cylinder was being filled to 200bar. **Download here**



Safety Alert - Casing stud failure on water injection pump

A stud (fastener) from the pump casing failed and was projected in the air. The system was operating at 120bar at the time. The stud landed on the deck approximately 1.4 meters away from the Operator. To find out more, **Download the alert.**


