7. Sites

7.1 Resurfacing of the Pétanque Piste at the Recreation Ground

During the discussion it was noted that ball play/nets were on the medium-term plan for the Recreation Ground Steering Group. The Council Officer noted the importance of submitting the required documents to the Clerk prior to a Parish Meeting to change a Parish Council Decision.

Decision R2025/7b A member of staff to organise a meeting with the Recreation Ground Steering Group, Clerk and Councillors to decide the correct way forward, and to report to the September Parish Council. **Agreed.**

7.2 Signage for dogwalkers to keep dogs on a lead.

Complaints have been received from members of the community with regards to dogs not being on leads or properly controlled by their owners. It was noted that signage is not always effective and there may be other methods that could be used. It was noted that that there was a reduction in areas for "free run" for dogs and that experienced dog walkers in Martlesham tend to be responsible.
