CERTIFICATE OF COMPLIANCE – REACH DECLARATION

EC Regulation 1907/2006 - Concerning the Registration, Evaluation, Authorisation and Restriction of Chemicals (REACH). This is an EU regulation which also applies in the UK. The REACH etc. (Amendment) Regulations 2019 No.758 also known as UK REACH apply from 30th September 2021.

The latest Candidate List was last updated 25th June 2025.

Registration – Does not apply to products we manufacture because we do not import nor manufacture chemical substances covered under the regulation.

Evaluation – Trojan Special Fasteners Ltd reviews the REACH guidance and evaluates it's products on an ongoing basis.

Authorisation and **Restriction** are the two REACH mechanisms/processes to regulate substances which pose concern to health and/or the environment. REACH 'Restrictions' may prohibit the use of a substance but more usually they restrict (or even prohibit) the supply of products containing it above specified thresholds.

Important definitions stated in Article 3 of REACH 1907/2006 and UK REACH 2019/758 & 2021/904

Substance – means a chemical element and its compounds in the natural state or obtained by any manufacturing process, including any additive necessary to preserve its stability and any impurity deriving from the process used, but excluding any solvent which may be separated without affecting the stability of the substance or changing its composition;

Preparation – means a mixture or solution composed of two or more substances

Article – means an object which during production is given a special shape, surface or design which determines its function to a greater degree than does its chemical composition.

The regulations require all substances, mixtures and preparations to be registered. However, articles are not governed by REACH and thus do not require registration. Trojan Special Fasteners manufactures fasteners from hexagon, round and square bar in the following metals which it classes as <u>articles</u> and thus do not require registration:

Aluminium (2011T3)	0.20 - 0.40
Brass CZ121/CW614N	2.50 – 3.50
Naval Brass CZ112/CW712R	0.20 - 0.60
Bright Mild Steel 230M07Pb/EN1APb	0.00 – 0.35
Phosphor Bronze PB1	0.00 – 0.25
Leaded Bronze/Phosphor Bronze LB2/LB5/PB2	10.00 – 11.50

For this reason, Trojan Special Fasteners Ltd can confirm that products supplied to you are classified as articles and therefore do not need to be registered under REACH.

All articles containing lead will have containers marked with their respective materials and paperwork will state "Contains Lead" as per Article 33. Also, safe handling paperwork is available on our website at trojansf.co.uk/legal

This policy will be evaluated annually to ensure compliance.
