FIRST AID TRAINING

Workplace First Aid Regulations

The HSE First Aid regulations state that all workplaces, regardless of the number of employees, must have an **adequate and appropriate** first aid provision.

As an employer you have to decide on what adequate and appropriate means to your organisation by completing a first aid risk assessment.

Your risk assessment should assess

- The type of work being undertaken by employees and whether it presents a higher level of accident/injury risk
- Existing injuries/ailments of employees as to who might be more at risk of becoming ill at work or having an accident.
- The number of employees, location of where they are situated and shift patterns.

As a minimum you need to ensure there is someone who can give immediate assistance in the event of an emergency, at all times there are employees on the premises and that your first aid supplies are suitable to meet the needs of any incident which may occur.

Even if you only have one employee on your premises, you will still need to provide a suitable and adequate first aid provision.

Suitable First Aid Courses

There are only two HSE recognised and accepted first aid courses considered suitable for the workplace:

- Emergency First Aid at Work 1 day course suitable for low risk environments such as offices, libraries, shops and small businesses.
- First Aid at Work 3 day course, suitable for high risk workplaces. This would include manufacturing, assembly, maintenance, construction, hot works, places with visitors and members of the public.

Our regulated first aid courses are certificated through Qualsafe Awards who are an Ofqual Approved Awarding Organisation.

Certification will last 3 years from the end of the course date and will carry an official Ofqual Watermark of quality.





Choosing your First Aiders

You should select your first aiders carefully, and give consideration to the following points.

- Location in the workplace so that those with the highest level of skill are closest to the areas of highest risk.
- General disposition at remaining calm in a crisis.
- Fitness levels, especially if they are likely to have to run a fair distance to get to the furthest point of your workplace, or to get help.
- Ability to understand and communicate with Emergency Crews in English.
- Mobility for kneeling, bending and perhaps in an emergency, dragging an injured casualty.
- Physical strength sufficient to deliver CPR over a period of at least 8 minutes until help arrives.
- Mental health to deal with possible trauma.

Requalifying on expiry of certification.

- In order to operate as a First Aider in the workplace, the first aid certificate must still be in-date. There is no longer a "grace" period where those who have allowed their certificate to expire can operate as a first aider at work.
- Ideally learners should renew their qualification before it expires. However, you are allowed to renew a First Aid at Work qualification within 1 month of the certificate expiry date, without having to retake the full 3 day course again.
- For those holding the 1 day Emergency First Aid at Work qualification, the requalification is to complete the same course again.
- For those holding the 3 day First Aid at Work qualification, the requalification is to undertake a 2 day First Aid at Work Requalification course.

- The HSE strongly recommends that ALL First Aiders, regardless of level, complete a 3 hour Annual Refresher course in each 12 month period, following the date of certification.



Annual Refresher

The HSE Strongly recommend that ALL first aiders, regardless of the level of qualification complete 3 hours of refresher training in each 12 month period, following the date of original certification.

Although this is not a mandatory requirement, the HSE have identified that skill fade over a three year period, is quite significant, and that the confidence level of first aiders is significantly affected where refresher training has not taken place.

In order for your first aiders to feel confident at all times, with their skill levels and ability to cope, you should consider ensuring their training is kept up to date annually.

HEALTH AND SAFETY TRAINING

Health and Safety At Work etc Act.

The Health and Safety at Work etc Act 1974 lays down the duties of employers to protect the health, safety and welfare of all of their employees while they are at work. There is also a duty for employers to take reasonable measures to protect visitors, members of the public and the self-employed while on their premises.

ALL workplaces in the UK are covered by these regulations, regardless of how big or small or how many employees there are. If there is one or more employees, then the regulations will apply.

In addition to the Act, the Management of Health and Safety at Work Regulations 1999 provide further details that identify the risks that employees, contractors, visitors etc may face and the steps required to control and mitigate those risks through the process of Risk Assessments.

In all aspects of Health and Safety at Work, the HSE will expect to see employers taking responsibility for providing quality training to their employees and keeping training records that can be referred to in the event of an incident.

MENTAL HEALTH at WORK

Mental Health is defined as the state of mental well-being that enables people to cope with the stresses of life, realise their abilities, be able to work well and enjoy a healthy social life.

It is estimated that 25% of employees struggle silently at work with issues that cause them stress and anxiety, while 12% of employees take time off work with mental health related conditions and 76% of employees report feeling stressed at work.

Stress, Anxiety and Depression are the most common forms of poor mental health.

Many people are reluctant to discuss they are struggling with mental health related issues to their colleagues or managers for fear of a negative response. Therefore it is vital that everyone is able to recognise those common symptoms so that help and support can be provided. Common symptoms can include:

- Low levels of motivation and engagement in their job role
- Changes in characteristics and behaviours
- Appearing tired
- Not eating well
- Increase absenteeism
- Irrational fears and anxiety
- Lack of social engagement
- Drug or alcohol dependency.

TAQA Assessment Qualifications

Training, Assessment and Quality Assurance (TAQA) Awards are a nationally recognised suite of qualifications that are required to be held by those who wish to assess the competence of learners who are working towards qualifications with national standards such as NVQs and VRQs.

There are different pathways through the Assessor Award qualifications to suit the type of assessing the candidate assessor will be undertaking.

Pathway 1—Theory Unit only: Understanding the principles and practices of assessment.

This unit is the mandatory unit across all other pathways, but can be taken as an individual stand alone unit: £260 + vat—self study and assignment.

Pathway 2— Understanding the principles and practices of assessment PLUS Assessing Occupational Competence in the Workplace. This two unit award is suitable for those who may wish to assess qualifications completed fully in their learners workplace environment.

About the Assessor Awards

In order for the candidate assessor to undertake these awards, they need to be currently working in a role that allows them access to at least two learners who are working towards qualifications with national standards. These learners must be allocated to the candidate assessor who must take responsibility for assessing their programme of learning.

The assessor candidate will need to participate in various standardisation activities and have a logged programme of CPD Activities throughout this award in order to meet the standards, therefore an Internal Quality Assurance system must be also in place within the organisation.

Assessor candidates are required to be experienced and competence themselves in the subjects they are assessing their learners against.



TAQA L4 Internal Quality Assurance

Training, Assessment and Quality Assurance (TAQA) Awards are a nationally recognised suite of qualifications that are required to be held by those whose role is to provide a robust system of Quality Assurance within the Assessment Processes carried out by their team of assessors.

The IQA candidate will need to have a minimum of 2 qualified assessors allocated to them who each have 2 learners allocated to them who are working towards qualifications with national standards.

The IQA Candidate will need to be in a position of authority with the assessment team, and be able to arrange and organise standardisation meetings, training and development programmes to support assessors, and liaise with Awarding Organisations on External Quality Assurance visits/arrangements.

The IQA will need to demonstrate development of IQA Planning, IQA Activities and IQA Reviews of planned activities outcomes.

For those working towards the L4 Certificate in Leading the IQA Process, they must already hold the L4 Award in Internally Assuring the Quality of Assessment.

 their FIRST Driver Qualification Card by
 attending 35 Hours of Classroom Based CPC
 Training
- Drivers taking their car test after 01.01.1997
 but their vocational HGV test before
 10.09.2009 have inherited rights as an existing truck driver and they are also eligible to gain their first DQC Card by sitting 35 hours of classroom based Driver CPC training.
- Drivers who took their HGV Test on or after 10.09.2009 and who have NEVER had a DQC Card have no eligibility to gain their first DQC Card by undertaking classroom based training. These drivers have only sat their Part 1 and Part 3 Vocational Test (Theory + Practical Ability Test) which has given them the Weight Category, but NOT the full qualification to drive as a professional driver. This is usually the case with Military Drivers or those who have been driving a large vehicle for their own business use. In order for to drive as a professional driver and drive for Hire or Reward, the driver must book in to complete Parts 2 and Parts 4 of the Initial CPC Tests—Case Studies, and Practical Loading/walk around checks. At the end of Module 4, a DQC card will be issued



Driver ID requirements to attend training

Drivers must bring with them to ALL Periodic CPC Courses, BOTH their Driving Licence and DQC Card if they have one, even if expired. This will confirm their eligibility to attend. If they do not have a DQC Card, we can then check eligibility using their Driving Licence Vocational Date. However, you should check this first BEFORE sending them to CPC Training as if they are not eligible to attend, their hours will NEVER be uploaded.

Paper Driving Licences

A driver can NEVER have a DQC Card if they still have a paper licence. Therefore they need to apply to swap their paper licence to a photo ID one if they want their 7 hours CPC Upload. This does not apply to FORS Silver SUD Courses for Van Drivers. The upload to FORS will take place on a B Licence.

Driver with an EU Driving Licence.

If a driver has an EU Licence/Swiss Licence and wishes to have a UK DQC card, they will need to exchange their Driving Licence to a UK Licence first. If they have a Code 95 on their driving licence, or a DQC Card from another country they should contact the DVSA on cpcre@dvsa.gov.uk giving their Name, Address, Driving Licence Number and phone number, asking to have their previously recorded DQC hours, applied to their new GB Licence. However, if they wish to retain their EU Driving Licence but gain a GB DQC Card

They will need to apply to the DVSA by email to CPCRE@dvsa.gov.uk to ask for a DQC1 form, which they need to complete and return once they have completed 35 hours of Driver CPC training, of which at least 7 hours needs to have been completed in the UK. They will then be issued with a GB DQC Card.

Driver with a GB Driving Licence and an EU DQC card. Validating CPC Hours

If a driver wishes to attend periodic CPC Training in the UK and wants the hours validating to their EU DQC card, the driver should scan the front and back of the EU DQC Card and email to cpcre@dvsa.gov.uk together with their name, GB Driving Licence Number, and home address. The DVSA will validate the hours of training for them. Please note this is NOT the process to obtain a GB DQC card. To do this please read the previous section.

Online Driver Enquiry Service.

All drivers should register with the ODE service, which can be accessed at www.gov.uk/check-your-driver-cpc-periodic-training-hours.. This service enables drivers to check to see how many Periodic CPC hours they have in the "bank" towards their next card when it is due. Drivers can also generate temporary passwords to give to employers, so that employers can see which drivers need to attend CPC training. This prevents spending money on training courses that are not required.



Can a driver repeat a CPC Course more than once in a 5 year period.

Yes they can, if there is a clear reason to repeat a module. Some drivers may require to hold a First Aid certificate. These generally only last 3 years, therefore it would be necessary to repeat the modules twice in a 5 year period.

This also might be the case for drivers who have frequent infringements on drivers hours, tachograph recordings or loading related issues. It is perfectly acceptable for an employer to require a driver to refresh their skills and knowledge on key critical areas such as loading and understanding the rules of drivers hours more than once in a 5 year period, or to prevent the loss of accreditation such as Earned Recognition, if a particular driver is found to be lacking awareness.

ADR drivers would also be required to repeat some training more than once.

The ruling that came out in 2023 is really there to prevent drivers being forced onto the same course every year, simply because it is the only one being offered by your training provider or approved by the employer organisation.

TRANSPORT MANAGER PROFESSIONAL COMPETENCE

The Certificate of Professional Competence in Road Haulage is the only qualification recognised by the Traffic Commissioner, and is a mandatory requirement to be held by all Transport Managers holding a Standard National or Standard International Operators Licence.

In May 2025, anyone who is using Light Goods Vehicles over 2.5 Tonnes but under 3.5 Tonnes to transport goods for hire or reward outside of the UK will also be required to have a fully qualified Transport Manager and hold a Standard International Operator Licence. This includes cars with trailers or 4x4s with trailers.

Standard O Licence operators must nominate a person who is professionally competent and who is responsible for licenced operations. Applicants must be suitably qualified and experienced. This can be an internal Transport Manager, or an External Contractor.

A part time Transport Manager is acceptable depending on the number of vehicles and trailers authorised on the O Licence.

Those operators on a Restricted Licence, do not require a Transport Manager.

Any one can become professionally competent as long as they hold this qualification, and have not lost their "Good Repute" status previously with other fleet operators, or by bankruptcy or criminal record.
