Spotlight on AWRC Training

Tackling Harmful Practices with Cultural Competency

In May 2025, AWRC delivered a focused training session Harmful Practices, including, forced marriage, virginity testing, and cultural competency. The session brought together 20 dedicated professionals from across Wandsworth, Richmond, and nearby boroughs, including social workers, hospital IDVAs, health practitioners, refuge staff, and VAWG officers.

These practices continue to violate the rights and dignity of women and girls, often hidden behind cultural silence or systemic gaps. Our training challenged those silences, equipping professionals with the knowledge to identify warning signs, respond with empathy, and act with cultural sensitivity. Crucially, it reinforced that specialist services like AWRC are not optional add-ons, they are essential lifelines.

These services offer the expertise, trust, and tailored support that general services alone cannot provide.

Participants described the session as transformative, noting its direct relevance and immediate value to their day-to-day roles. The training sparked focused engagement and practical discussions that many said they could immediately put into action.

The event brought together feminists, activists, VAWG sector organisations, by and for agencies, funders, and passionate individuals who build solidarity, share a commitment to learning, and support the ethos of the Coaction Hub. It created a powerful space to reflect honestly on what has been achieved, the learning generated, and the ongoing challenges in the fight for systemic change.

At the heart of Coaction Hub's success is its commitment to doing things differently—centring the expertise of 'by and for' organisations, challenging the status quo, building solidarity, cocreating resources and holding space for difficult but necessary conversations.

Coaction Hub has marked several significant milestones this year. Research was conducted into the effectiveness of MARAC (Multi-Agency Risk Assessment Conferences) in responding to harmful practices cases, accompanied by the development of a good practice toolkit to support professionals. Targeted training was delivered to **MARAC Coordinators across** England and Wales, focusing specifically on harmful practices and the role of MARAC in these complex cases. A Domestic Homicide Review (DHR) mentoring initiative was launched to support women working in specialist 'by and for' agencies to become DHR Chairs, alongside workshops for agencies interested in joining DHR expert panels.



Reflections on the Coaction Hub Learning Event

Coaction Hub also carried out a review into the effectiveness of current risk assessment tools for Black and minoritised survivors of domestic abuse and harmful practices, identifying key areas for improvement. Additionally, international VAWG (Violence Against Women and Girls) intervention models were explored to assess which approaches could inform UK practice. Finally, a Knowledge Hub was developed to collate co-created learnings from the project and provide links to useful resources.

A participant reflected,

"Projects grounded in the ethos of equitable partnerships and collaboration, like the Coaction Hub, can only thrive when there is space for uncomfortable conversations and the courage to challenge and disrupt norms and structural hierarchies. There was deep learning around what it means to lead with care and lead with feminism. When we do, the impact becomes more reflective of the women we aim to support. This partnership is unique from their MARAC trainings, DHR mentoring to research to create systemic change."



Harmful Practice Independent Domestic Violence Advocate (HP IDVA) Programme

The Harmful Practice Advocate (HPA) Programme is a pioneering initiative developed by the AWRC to equip practitioners and advocates in the ending Violence Against Women And Girls (VAWG) sector with specialised knowledge and skills, essential for navigating challenges associated with harmful practices and effectively address and tackle harmful practices within VAWG. The course delves into the nuances of harmful practices and their impact on marginalised communities.

Our course is uniquely accredited by AAL and endorsed by the Ofqual regulated governing body NCFE. It stands as the only one in the UK specifically focused on Harmful Practices.

Rooted in a Black Feminist perspective and an intersectional approach, the Harmful Practice accredited Programme is designed to enhance the skills of frontline workers working within the ending VAWG sector.



Read Coaction Hub's latest research paper, "Rethinking Risk Beyond the Checklist: The Need for a Holistic and Inclusive Framework."

The paper addresses a critical gap: the lack of research exploring how current risk assessment tools reflect the lived experiences of Black and minoritised victim-survivors. Aimed at VAWG practitioners, policymakers, and frontline professionals, the paper calls for a shift from a solely risk-led model to one that integrates both risk and needs—centred on survivors' lives, not just incidents.

Key recommendations include:

- Making risk assessments inclusive, holistic, and trauma-informed
- Establishing long-term funding for consistent, survivor-centred support
- Reviewing and co-creating tools like the DASH RIC with input from survivors and specialist services
- Improving coordination across sectors by identifying and sharing best practices

Clinician training covers 5R's:

- Recognise domestic abuse in health presentations
- Ask and Risk check

IRIS only accepts Standard and Medium Risk referrals and the training counts towards Level 3 Safeguarding. Our training is FREE!
