

Identify locations where people are actively involved in preventing damage to the environment.




- Introduce a 5p charge on single-use plastic straws.
- Ban energy-wasting open fridges and freezers in all retail outlets
- Help fund the cost of redistributing more edible surplus food to charity.

## **Petitions used**

- Make ECOCIDE a UK criminal offence
- Convert fossil fuel subsidies into subsidies for renewable energy
- Declare a Climate Emergency end fossil fuel use and build community resilience.
- Restore nature on a massive scale to help stop climate breakdown
- Reduce and end unnecessary single-use plastics
- Install microplastic filters on new washing machines as standard
- Stop the increase to 20% VAT for the installation of renewable energy sources
- Demand the EU & UN sanction Brazil to halt increased deforestation of the Amazon
- Ban the use of all non-recyclable and unsustainable food packaging
- Require supermarkets to offer a plastic-free option for all their fruit & veg.
- Consult with focus groups of young people when creating climate change policy
- Ban the sale of products containing unsustainably sourced palm oil in the UK
- The UK Government to introduce a ban on all non-recyclable packaging from 2022.

## **Petitions used**

- Ban peat compost.
- Repeal the archaic Weeds Act 1959 to benefit pollinators and wider biodiversity.
- Increase the penalty for developers and landowners who remove trees illegally.
- Outlaw planning applications that include removal of mature trees or hedgerows.
- Ban balloon and sky lantern releases.
- Ban balloon and sky / chinese lantern
  releases
- Cease all new developments on Greenbelt and Greenfield sites across the country.
- Amend the 1967 Forestry Act to protect endangered wildlife habitat across the UK
