

## **Support strong UK borders**


Identify locations where people are interested in the support for strong UK borders.

- Begin a process of removal of illegal immigrants in the UK.
- Rule out any prospect of granting an amnesty on illegal immigration
- Ban Isis fighters from returning to the UK
- Ban all ISIS members from returning to UK

## **Petitions used**

- Give British Citizenship to all EU citizens currently living in UK if no deal
- Allow Tier 2 (Intra-Company) individuals and their dependants to settle.
- Automatically grant EU citizens in the UK indefinite leave to remain for free
- Amnesty for illegal immigrants who have been in UK for 10 years
- Introduce super visa category for parents of British citizens similar to Canada
- Introduce automatic approval of visit visas for families of British Citizens
- Lower the cost of British Citizenship applications to £372.
- British National (Overseas) Citizens should be given full British Citizenship.
- Provide settled and pre-settled status EU citizens a physical document as proof.
- Change Settlement Status from Application to Registration.
- Keep the rights of EU27 + EFTA citizens already in the UK unchanged after Brexit
- Amnesty for anyone who was a minor that arrived In Britain between 1948 to 1971
