Chairs Report

In the year that we changed our name to include Carisbrooke, I was elected for a fourth time in 11 years to be Parish Chair. I stand down in May and in some ways it will be something of a relief.

Our 11th year augured well for the future with the *Shaping Newport* report and aspirations, and our subsequent agreement to produce a Strategic Plan for the parish council in consultation with residents.

We did all of that, resulting in our recent Budget increase to deliver the services that YOU want; services that have been ended by the IW Council, due to Government funding cuts.

However, it has been very hard to deliver all we set out to do last April as our then new Clerk felt he had to resign half way through the year. The Parish Clerk is the key role within a parish council, ensuring that the aspirations of councillors can be delivered.

We have since appointed Jonathan Baker as our new Clerk, promoted our two administrators (Laura Jones and Lucy Molyneux) to Assistant Clerks as well as appointing a Finance Officer to manage our increased budget and an Assets and Facilities Manager to help in the delivery of services. I believe we now have the right team in place to move the parish council forward in accordance with its ambitious plans and significantly increased financial resources.

In the last year we also moved to The Guildhall; home of Newport Borough Council until its abolition in 1974. As we do not have access to the ground floor and there is no working lift, we use Lord Louis Library for our open sessions.

My thanks go to all our staff and to supportive colleague councillors over the past year, in particular my Vice Chair, Cllr Julie Jones-Evans who has been an absolute rock during a very challenging year.

Please be aware that these are not audited figures so should be treated as draft. **NB** that last year's figures were on a Receipts and Payments accounts system, this year they are on an Income and Expenditure system. Therefore the figures are not "like for like". At this point next year the figures will be comparable.

MEETINGS

Full Council meetings are held on the second Monday of each month except August, when no meeting is held. We rotate the locations around the wards and meetings begin at 6.45pm. Members of the public are able to participate during the 15-minute public session at the beginning of each meeting, where questions can be raised relating to business not included on the agenda.

The Planning and Licensing Committee meet every three weeks on a Thursday evening beginning at 6.30pm. The Assets and Facilities Committee meet on the last Tuesday of each month (except August) beginning at 6.30pm. Both these committees meet at The Pavilion, Victoria Recreation Ground. Agendas will be posted on the parish council's website and notice boards at least three clear working days ahead of the meeting. Members of the press and public are always welcome to attend. Full details of all meetings can be found on the Parish Council website.
