#### 130/18 Progress Report from the Clerk

118/18 b) To discuss the current 24-hour opening hours of the TDC Market Place car park District Cllr. Coley informed the council that he had been in discussion with the officers in charge of car parks at TDC who are proposing a new contract going forward whereby both the public toilets and the Market Place car park will be closed at 6pm.

# 131/18 Reports from Representatives on various committees

# 132/18 To discuss a proposal to initiate a petition for an amalgamation of Manningtree, Mistley and Lawford (item 84/18)

**RESOLVED** that the council is in favour of requesting a Community Governance Review by TDC to look at the feasibility of a potential amalgamation of the three parishes of Mistley, Manningtree and Lawford. The clerk is to e-mail Mistley Parish Council and Lawford Parish Council to request that this goes on their agendas for discussion. It was agreed that the council would assess whether there is an appetite for an amalgamation from residents by posing the question on the council Facebook page and a joint press release with the neighbouring parishes should they wish to do so and vote in favour of requesting a Community Governance Review. a) To consider purchasing a speed indicator device for the town (item 69/17 c) and to discuss the results of the speed survey

Based on the results it was **RESOLVED** that the clerk put together a THLP scheme for consideration at the next full council meeting to request a 20 mph speed limit within all of Manningtree, but in particular on Brook Street and High Street.

**RESOLVED** that the council will not be proceeding with this scheme at this point in time.

137/18 To consider request from Town Clerk to register for the CILCA qualification training through the EALC

**RESOLVED** that the clerk will register for the CILCA course. The council agreed to cover the costs of the course and pay the clerk salary for actual hours attending the course at the EALC Office in Great Dunmow. Any potential paid salary towards study time to complete the CILCA portfolios is to be considered at a later date.
