### 110/18 Apologies for Absence

Apologies were received from Cllrs. M. McClarnon, S. Richardson and J. Charlesworth.

#### 111/18 Minutes of the previous meeting

**RESOLVED** that the minutes of the meeting held on 15<sup>th</sup> November 2018, having been circulated previously, be approved as a correct record and signed by the Chair.

#### 112/18 Declarations of interest

There were none.

#### 113/18 Public Participation Session

There were four members of the public present including a member of the Manningtree Museum, all providing the council with their views on the potential closure of the Manningtree library. The general consensus was that the closure of the library would be a real loss to the local community. The library has a unique location being situated on the Essex / Suffolk border and most likely serves all surrounding parishes as well as Manningtree. If the library closes the nearest tier one Tendring library will be in Clacton.

Various members of the community are currently campaigning to keep the library open. The alternative to a potential closure would be for a community group / organisation to run and manage the library. It was pointed out that the library is not just used to borrow books but is also providing people with access to a PC and the internet, DVD rentals and is used regularly by several local groups as a meeting place.

Manningtree Museum is also located within the library building and are renting a room at the back paying a peppercorn rent. They are very concerned about what the future holds for the museum should the library close. The museum is a charity and are funded by small parish council grants, donations and fund raising. The museum would be a willing partner to any arrangement proposed by the community but would not be in a position to lead such an enterprise.

One member of the public put forward a proposal for the council to hold ECC to account via their Chairman John Jowers. This could not be voted on at the meeting as it was not on the agenda. The member of the public asked for the item to be added to the council's January agenda.
