Germany	Defra has reviewed the actions taken by the German Competent Authority in response to an outbreak of foot-and-mouth disease (FMD) that was confirmed on 10 January 2025 and concluded that the containment zone (DE-1) can be recognised as free of FMD from 14/05/2025. As a result, the suspension on imports of raw milk and raw dairy products (Column A) and heat-treated milk and dairy products (Column B) from DE-1 has been lifted. Footnote 'e' has been added to DE-1, which stipulates that 'for certification purposes, this territory is considered to have been free of FMD from 14/05/2025'.	14/05/2025
Austria	Imports from Austria of raw milk and raw dairy products (Column A) and heat-treated milk and dairy products (Column B) have been temporarily suspended in response to an outbreak of foot-and-mouth disease that was reported on the Hungary-Austria border on 26 March 2025.	27/03/2025
Slovakia	Foot-and-mouth disease was confirmed in Slovakia on 21 March 2025. The restrictions outlined in the entry dated 07/03/2025 continue to apply.	27/03/2025
Germany	Following an assessment of the measures implemented by the German authorities in response to an outbreak of foot-and-mouth disease (FMD) confirmed on 10 January 2025, the UK has recognised regionalisation for this outbreak. Imports of raw milk and raw dairy products (Column A) and heat-treated milk and dairy products (Column B) from FMD-free zones in Germany (DE-0) are now permitted. Imports of raw milk and raw dairy products (Column A) and heat-treated milk and dairy products (Column B) from zones under restriction due to outbreaks of FMD in Germany (DE-1) are prohibited. Imports of milk and milk products under Column C are permitted from the whole territory of Germany.	24/03/2025

Column C lists those countries authorised for the importation of dairy products derived from raw milk of cows, ewes, goats or buffaloes, or, where specifically authorised, from camels of the species Camelus dromedarius at risk of foot-and-mouth disease provided that the dairy products have undergone, or been produced from raw milk which has undergone, an appropriate heat treatment, in accordance with Article 4 of EUR 2010/605 (c).

- a The colostrum and colostrum-based products can only be introduced into Great Britain from countries authorised in column A.
- b Ovine and caprine products are suspended.
- c The product must undergo one of the following treatments:
 - a) a sterilisation process, to achieve an Fo value equal to or greater than three; or
 - b) an ultra-high temperature (UHT) treatment at not less than 135°C in combination with a suitable holding time; or
 - c) (i) a high temperature short time pasteurisation treatment (HTST) at 72°C for 15 seconds applied twice to milk with a pH equal to or greater than 7.0 achieving, where applicable, a negative reaction to a alkaline phosphatase test, applied immediately after the heat treatment; or
 - (ii) a treatment with an equivalent pasteurisation effect to point (i) achieving, where applicable, a negative reaction to an alkaline phosphatase test, applied immediately after the heat treatment;
 - d) a HTST treatment of milk with a pH below 7.0; or
 - e) a HTST treatment combined with another physical treatment by either:
 - (i) lowering the pH below 6 for one hour, or
 - (ii) additional heating equal to or greater than 72°C, combined with desiccation.
- d For certification purposes, this territory is considered to have been free of FMD for more than 24 months.
- e For certification purposes, this territory is considered to have been free of FMD from 14/05/2025.
- f Raw bovine products are suspended. Bovine milk and dairy products that have undergone a lower heat treatment than pasteurisation continue to be permitted under General Authorisation IMP/GEN/2024/01.
