EU Member States	Under the Border Target Operating Model (BTOM), the UK recognises highly pathogenic avian influenza (HPAI) regionalisation of EU Member States by cross-referencing EU legislation. Imports of live poultry (BPP, BPR, DOC, DOR, HEP, HER, SRP, SRA, LT20) and fresh poultry meat (POU, RAT, WGM) are prohibited from zones in EU Member States under restriction due to outbreaks of HPAI, from the date of confirmation of disease (closing date) until the date restrictions are lifted (opening date).	26/01/2024
