

**VOUCHERS CONDITIONS OF USE**  
**BNETWORK ACCOMMODATION - MIPIM September Edition 2021**

All reservations made for MIPIM September Edition 2021 via bnetwork are subject to the general booking terms and conditions published on [www.mipimseptemberedition.bnetwork.com](http://www.mipimseptemberedition.bnetwork.com)

In the specific case of the use of a voucher for your MIPIM September Edition 2021 reservations, the following additional conditions apply :

**1. Use of the vouchers**

Credits from your MIPIM March 2020 reservations are only valid at the issuing hotel and cannot be transferred to another hotel.

Vouchers may be used at MIPIM September Edition 2021 **subject to availability at the hotel concerned for the requested dates.**

Credits are non-refundable. In case of partial use of the voucher, the remaining amount will not be refunded but will be carried over to MIPIM 2022.

**2. Changes and cancellation policy**

**2.1. Cancellation policy**

bnetwork accommodation department must be notified of any changes or cancellations as soon as possible. If you made your reservation via our online accommodation booking tool ([www.mipimseptemberedition.bnetwork.com](http://www.mipimseptemberedition.bnetwork.com)), you are able to check or modify your booking online.

- For all cancellation made **until June 08<sup>th</sup> 2021, included**, no penalty will be applied. The full amount of your voucher will be carried over MIPIM 2022.
- For all cancellation made **between June 09<sup>th</sup> and August 6<sup>th</sup> 2021, included**, one (1) night will be charged per room cancelled. The balance of your voucher will be carried over MIPIM 2022.
- In case of cancellation or shortened stay **after August 7<sup>th</sup> 2021, included**, the full amount of the reservation will be charged.

**2.2 Exceptions**

By exception, the deposit paid by a company attending will be fully reported to MIPIM 2022 in the following cases :

- Travel ban issued by the government of residence of a person for whom the delegate has made a reservation
- Quarantine imposed by France or by the government of residence of a person for whom the delegate has made a reservation
- Medical certificate attesting to a positive COVID 19 serology from a person for whom the participant has made a reservation.

- Closure of the borders by the accommodated visitor's country or by France.
3. **Cancellation or report of the event due to COVID-19**

In case of cancellation or postponement of the MIPIM September Edition 2021, bnetwork will be able to cancel the reservation without being held to compensation. In this case, bnetwork will refund the deposit paid, according to the general terms and conditions of the concerned hotel. The general conditions of refund from the hotel in case of cancellation by the MIPIM organizer, except any case of "Force Majeure", are available on simple request to [hotel.mipim@bnetwork.com](mailto:hotel.mipim@bnetwork.com).

For your information, most of the hotels have agreed on the following conditions :

- **Until August 08<sup>th</sup> 2021, included:** no penalty fee and deposit paid reported to MIPIM 2022.
- **Between August 9<sup>th</sup> to August 26<sup>th</sup> 2021, included:**
  - client having a 60% report from MIPIM 2020 : no penalty fee and deposit paid reported to MIPIM 2022.
  - client having a 100% report from MIPIM 2020 : 20% penalty fees and 80% of the deposit paid reported to MIPIM 2022.
- **From August 27<sup>th</sup> 2021, included:**
  - client having a 60% report from MIPIM 2020 : no penalty fee and deposit paid reported to MIPIM 2022.
  - client having a 100% report from MIPIM 2020 : 40% penalty fees and 60% of the deposit paid reported to MIPIM 2022.
