GPC England meeting

GPC England held its meeting on Thursday 16 November. At that meeting GPC England:

- Received an update from policy leads and the GPC England Executive
- Received an update on the GMS contract negotiations
- Following the results of the survey of GP practices in England on collective list closure and the decision to increase lobbying activity, the GPC launched a major publication entitled ‘Saving General Practice’ (SGP), which outlines the critical issues that must be addressed by government in order to rescue general practice from the crisis it currently faces. GPC England received an update on the strategy to increase pressure on government and deliver the actions within SGP.
- Discussed the BMA’s response to the consultation regarding proposed changes to the regulations of the Accountable care models contract
- Received an update on the Scottish GPC contract
- Received and discussed a proposal to appoint a Speaker to chair GPC England meetings, similar in style to that of the House of Commons
- Received resolutions from the Conference of England LMCs
- Received an update on NHS England’s urgent care review
- Received an update on the NHS e-referral Service
- Received an update on the Delayed Transmission of Hospital Letters

The next meeting of GPC UK will take place on Thursday 15 March 2018 and the next GPC England will take place on Thursday 18 January 2018.

'Give the gift of 5 minutes' campaign

As you may have heard, the BMA are running a campaign aimed at encouraging doctors to take 5 minutes during their day, to focus on their mental health. Phase one of the campaign is called ['give the gift of 5 minutes'](#) and runs through to the end of December. Phase two – 'take 5' will then run until the end of January. To support doctors in taking 5 minutes to unwind and focus on their mental health, we're giving two months' free trial of Headspace – the mindfulness and mediation app.

Extension of the seasonal flu programme to include social care workers - England

NHS England has announced that for the 2017/18 flu season, the delivery of flu immunisation will be extended to include social care workers that offer direct patient care.

The [influenza vaccine PGD template](#) has been amended to include the vaccination of health and social care staff, employed by a registered residential care/nursing home or registered domiciliary care provider, who are directly involved in the care of

vulnerable patients/clients who are at increased risk from exposure to influenza, meaning those patients/clients in a clinical risk group (see [Appendix A](#)) or aged 65 years and over.

Note that the previous version (v04.00) is not being formally withdrawn in order to ensure continuity of service and may still be used this season (until 31 March 2018). However, this new version of the PGD will be needed to vaccinate health and social care staff in line with the NHS commissioned service when it is commenced.
