

Dear Humber Primary Care Collaborative Stakeholders,

At the first Humber Primary Care Collaborative (HPCC) meeting on 2 June 2021 we agreed to undertake a vote on shortlisted options for primary care leadership representation in the ICS.

The closing date for voting was 11 June 2021 and votes received were as follows:

Option 1 – 1 Vote

Option 2 – 8 votes

Did not vote – 10 votes

The LMC will therefore record that Option 2 is preferred by HPCC and will promote this to ICS stakeholders as the preference of primary care providers. The voting options are set out below for reference.
