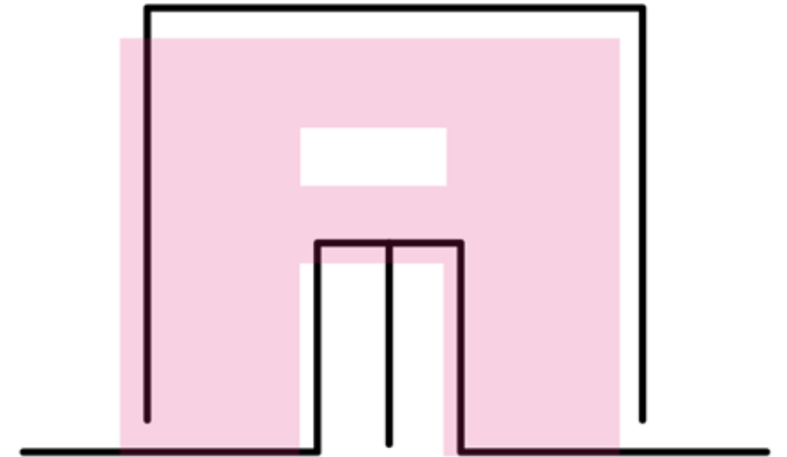
BMA – Partnership Support

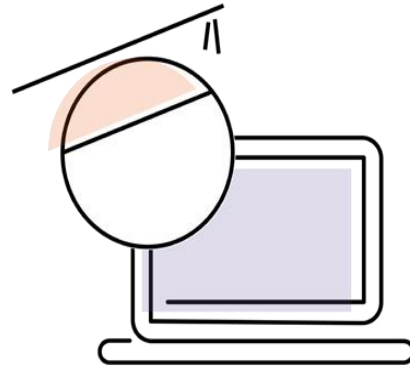

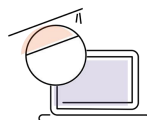
