MINUTES of the NORTH WALES RUGBY COUNCIL HELD IN THE CONWY SUITE, PARC EIRIAS ON MONDAY 12<sup>TH</sup> JANUARY, 2015 AT 7.00pm

Prior to the commencement of the meeting, a moment's silence was observed in memory of Selwyn Goldsworthy, long serving stalwart of Dolgellau RFC

1. **Apologies:** Greg Burridge (Holyhead), Will Morcombe (RGC), Phil Parry (North East Wales District), Alwyn Bevan (Executive) and Tony Parry (Bala). Apologies had also been sent by Gareth Davies (Chairman, WRU) who had been scheduled to make a presentation at this meeting.
2. **Presentation** by Craig Maxwell, WRU Ticketing Manager

CM provided an update on the ticketing situation over the past nine months. (A copy of his presentation will be distributed to NWRC Clubs and Organisations)

### **3. REPORTS**

**A. Business and Finance:** Stuart Waters reported on:

- a. that sponsors had been appointed for the North Wales Cups- names of sponsors to be released after the official launch
- b. Accounts- positive balance was reported.
- c. Cup Final Extravaganza- arrangements were confirmed for 2<sup>nd</sup> and 3<sup>rd</sup> May
- d. WRU Trust Dinner Update- all 100 tickets had been sold. Final arrangements were confirmed. DD thanked SW for all his hard work on this project.

**B. The 'Game':** Geraint Morgan reported on:

- a. YPDP Clubs- meeting arranged for 19<sup>th</sup> January
- b. School Club Hubs – please see 3 Ea below
- c. National leagues 2015-16- all Clubs had been contacted to seek their views and wishes. Nine Clubs had replied. The recommendation from AB and GM that the information obtained from the Clubs should be considered when writing to the WRU with specific requests regarding next season's fixtures was accepted.

Tegid Phillips provided an update on the North Wales Cups and the North Wales 2<sup>nd</sup> XV league. Enquiries had been made with 7 Clubs regarding their intentions for their 2<sup>nd</sup> XVs next season i.e. the four Clubs in Division 1 North who are not members of the North Wales 2<sup>nd</sup> XV league and also the three Clubs vying for promotion from the 2<sup>nd</sup> division

He also reported on the lack of response from Mal Beynon of the WRU Regulatory Committee concerning NWRC's request that the Swalec Plate and Bowl should be a national competition at the last 32 stage rather than the last 16 as it is at present. **ACTION:** AJ to make enquiries

**C. Media and Communication:** HR reported on:

- a. the improved rugby coverage in the Daily Post

**D. RGC 1404:** Rupert Moon reported on:

- a. the WRU and Conwy BC agreement was being discussed on Tuesday, 13<sup>th</sup> January
- b. Chris Horsman had been appointed as a skills coach within the WRU. Phil Davies had been appointed until the end of the season as a consultant. Part of his role is to review processes and structures within RGC and North Wales
- c. RGC had an outstanding win the previous Saturday beating Neath away in the Swalec Cup.
- d. Wales are scheduled to train in North Wales on 11-13 August.

**E. Rugby Development Report:** MR reported on:

- a. school club hubs- that there was definite interest from a number of schools, but that the WRU had, as yet, not decided on the funding available for the roll out of the project.
- b. the record number of Juniors who were registered with the Clubs in North Wales

**F. District Representative** AJ reported on:

- a. Mid Wales will have a voice on the WRU League Structure working party
- b. Llangollen ad Rhos being two of the fifteen clubs who had applied for WRU status **ACTION:** AJ to send criteria for obtaining WRU status to TP to distribute to the Clubs
- c. the WRU had established a group to investigate the use of Digital Systems within the Union in order to negate unnecessary duplication
- d. CASC- all Clubs should have received a letter from the WRU.

**ACTION:** All Clubs to forward any feedback on the CASC process to AJ

- a. Dai Davies reported that the Executive was looking at whether the various organisations within the NWRC should be involved to a greater extent within the Executive
