How to nominate

Nominations can be made by anyone using an online form via the link highlighted in the award categories below. The closing date for nominations is 31st May 2019. After the closing date, the local County Cricket Board will judge the entries selecting an overall winner for each category. All county winners will be invited to an ECB Coach Awards event later in the year. A national winner and two finalists for each category will be selected by an ECB panel.
