Online Course Booking

Since July 2012 over almost 50000 people have accessed a variety of RFU education & training courses in First Aid, Refereeing, Coaching, Safeguarding and other volunteer roles. In July 2013 we implemented the online booking system with the aim of reducing pre and post course administration, accelerating the booking process and making it easier for people to search for and book places on courses. Whilst we continue to make improvements to the current system we have welcomed feedback from customers on additional functionality required by their clubs. This feedback is being used to shape the future ecommerce platform that meets the needs of clubs and individuals.

Sports Goggles Communication

In recent weeks we have received an increasingly large number of queries in relation to the wearing of goggles and thought it would be helpful to clarify the current position.

The RFU's regulation relating to the wearing of spectacles or sports goggles is set out in Regulation 15.13.3 which states that players of all age grades are permitted to wear spectacles, glasses or specifically designed sports goggles in all forms of non-contact rugby but not in any form of contact rugby. This means that U9s and above are not permitted to wear any eye wear when playing contact rugby. This is not a change in regulation from last year but a clarification only.

The prohibition on sports goggles in contact rugby stems from IRB Regulations (IRB Law 4/IRFB Regulation12). The RFU recognises that this prohibition is not socially inclusive and creates difficulties for children with impaired eyesight who

are not yet able to wear contact lenses. For these reasons, the RFU is talking to the IRB to permit U12s and below to wear sports goggles, subject to certain conditions.

The RFU and IRB are undertaking significant work to reach a common consensus on this as quickly as possible and we hope to be able to report back on a definitive positive solution shortly after the New Year. In the meantime, the RFU requests that all players, coaches and parents continue to abide by RFU Regulation 15.13.3 until further notice.

Please rest assured that the RFU is making significant progress on this issue and is dealing with it as a matter of urgency.

Community Amateur Sports Club (CASC update)

The Government has announced changes to the Community Amateur Sports Club (CASC) scheme following its consultation this summer. As you will be aware, the RFU and other governing bodies have been engaging with the Government on this for an extended period of time to try and ensure the best possible outcome for rugby clubs.

We should be conscious that it remains a challenging financial climate with Government having little capacity to grant tax or rate reliefs for any sectors. We are therefore pleased that Ministers accepted the principle that sports clubs deserve such reliefs because of the important work they do in communities. This acceptance is in part due to the number and strength of contributions made by rugby clubs to the Government's consultation.

The key focus for the RFU was to ensure clubs were able to generate reasonable levels of social income to invest back into rugby, and we are comfortable with the caps proposed. Other changes are detailed below.

The RFU welcomes the announcement on CASC. We need to work through the detail, but the Government has moved a considerable distance in the right direction. We believe that the changes will offer more benefits to existing rugby clubs, clarify the eligibility rules, and enable more rugby clubs to become CASCs in future. Given that being a CASC is worth approximately £4,500 to an average rugby club per annum, this is a significant step forward. Overall there is a £1.6m benefit per annum from the CASC scheme.

NatWest RugbyForce 2014 is open

England teammates Joe Marler, Christian Wade and Dave Attwood joined forces on the evening of the 4th November to kick off NatWest Rugby *Force* 2014.

Last year's programme was a great success, with over 400 clubs and 8,000 volunteers across England taking part in the DIY weekend in June. This year's NatWest Rugby *Force* will take place from **Saturday 21st to Sunday 22nd June 2014** and promises to be another great weekend.

Please encourage clubs to sign up before **January 17th** 2014 to be considered for the workshops and grants on offer. 175 clubs will be selected to take part in a project planning workshops. There will be 35 workshops taking place in March 2014 across the country.

If a club attends a workshop, they will receive £500 to go towards their NatWest RugbyForce Weekend and two clubs from each of the 35 workshops will be selected to receive enhanced support of £2,000 or £1,000.

Young Rugby Ambassadors presents a great opportunity for young people to showcase their talents and preparation to move into leadership positions within their own clubs. They can also to make a tangible contribution to growing the game and raising their club's profile in their local communities, not to mention getting insider information about RWC 2015! We are currently planning phase 2 of the programme, which will take place in April/May 2014 with a further phase (3) later in the year. Strengthening Connections between CBs and Education

It is there for the whole game with all CBs benefitting from the insight and communication channels provided. The network will support geographic CBs to develop their local programme and aims to bring a more joined-up and informed approach to planning and delivery.

The Reps will be in touch with you in the coming weeks and over time provide a good source of information, guidance and advice to help us all maximise the impact of the educational environment on rugby union; as well as ensuring that the plans of the national education Unions reflect the local and county picture.

RFU Volunteer Recognition and Reward Programme

The RFU Recognition and Reward programme is being updated! We want to recognise those individuals who have significantly contributed to strengthening our clubs and growing the game in the communities around them, and where an impact can be seen in even a relatively short time scale. At the same time, it is equally important to recognise those volunteers who have committed themselves to long service in rugby in whatever roles they have undertaken. We will soon be launching an annual recognition programme to enable CBs and clubs to:

- Plan in advance, budget and manage volunteer recognition expectations and opportunities throughout the game
- Highlight the type of volunteer and/or type of contribution, and the impact on the game, that we should recognise
- Say 'Thank You' in more innovative ways to more people and in front of more people
- Raise their profiles locally and nationally, which will aid volunteer recruitment and enhance our collective image & reputation
- Retain good quality volunteers by enhancing their quality of experience

To kick-start the process, this year we are producing a larger number of volunteer recognition certificates.

Each club will be allocated six certificates, bearing the signature of the President, Bob Reeves. By restricting the numbers but including every single club, we aim to both raise awareness of this form of recognition and also to make receiving a certificate a prestigious award.

The certificates will be mailed directly to clubs with the next edition of Touchline in early December.

Music licensing – new tariffs for sports clubs still not available

New legislation has ended the exemption for sports clubs in regard to obtaining a music license. However the new music licensing tariffs for sports clubs drawn up by collecting societies PRS and PPL is still awaiting official clearance.

Following consultation with the Sport and Recreation Alliance, PRS and PPL submitted tariffs to the Copyright Tribunal for collecting money from clubs which play music. However, the Tribunal has still not approved the tariffs which means that PRS and PPL cannot yet license sports clubs under the new proposed charging structure. Whilst the situation creates uncertainty for sports clubs, it does mean that many clubs continue to fall outside of the collection process and may not need to pay for a license until the end of the year when the tariff is signed off.

Already Paying for a License: Those clubs which already pay for a license through PRS are advised to contact PRS to discover whether they would be better off waiting to be licenced under the new tariff. Occasionally, clubs can find themselves in the wrong tariff for music licensing charges. To double check, here is the propriety rate guidance and the non-profit rate guidance.
