



# INTERLAW PRIVACY AND CONSENT TO USE OF DATA POLICY

#### **INTRODUCTION**

Welcome to Interlaw Limited's privacy policy. Interlaw Limited (Interlaw, we, us and our) are committed to protecting the privacy and confidentiality of personal data. This privacy policy will inform you as to how we look after your personal data and tell you about your privacy rights and how the law protects you.

# **PURPOSE OF THIS PRIVACY POLICY**

This privacy policy aims to give you information on how we collect and process your personal data through your use of our website, through data collected from you directly, through data collected from Interlaw member firms, your organisation and your clients.

It is important that you read this privacy policy together with any other privacy policy or fair processing policy we may provide on specific occasions when we are collecting or processing personal data about you so that you are fully aware of how and why we are using your data. This privacy policy supplements other notices and privacy policies and is not intended to override them.

#### **CONTROLLER**

Interlaw Limited is the data controller and responsible for your personal data.

# CHANGES TO THE PRIVACY POLICY AND YOUR DUTY TO INFORM US OF CHANGES

We keep our privacy policy under regular review. This version was last updated in April 2023.

It is important that the personal data we hold about you is accurate and current. Please keep us informed if your personal data changes during your relationship with us.



#### **THIRD-PARTIES**

Our website may include links to third-party websites, plug-ins and applications. Clicking on those links or enabling those connections may allow third parties to collect or share data about you. We do not control these third-party websites and are not responsible for their privacy statements. When you leave our website, we encourage you to read the privacy policy of every website you visit.

#### THE DATA WE COLLECT ABOUT YOU

Personal data, or personal information, means any information about an individual from which that person can be identified. It does not include data where the identity has been removed (anonymous data).

We may collect, use, store and transfer different kinds of personal data about you which we have grouped together as follows:



#### **IDENTITY DATA**

Includes first name, maiden name, last name, job title, date of birth and gender.



#### **CONTACT DATA**

Includes email address and telephone and fax numbers.



# TECHNICAL DATA

Includes internet protocol (IP) address, browser type and version, time zone setting and location, browser plug-in types and versions, operating system and platform, and other technology on the devices you use to access our website.



#### PROFILE DATA

Includes your username and password and preferences where you have registered for access to the Interlaw Members' Portal.



#### MARKETING AND COMMUNICATIONS DATA

Includes your preferences in receiving marketing from us and our third parties and your communication preferences.

We also collect, use and share Aggregated Data such as statistical or demographic data for any purpose. Aggregated Data could be derived from your personal data but is not considered personal data in law as this data will not directly or indirectly reveal your identity. For example, we may aggregate your Usage Data to calculate the percentage of users accessing a specific website feature. However, if we combine or connect Aggregated Data with your personal data so that it can directly or indirectly identify you, we treat the combined data as personal data which will be used in accordance with this privacy policy.

We do not collect any Special Categories of Personal Data about you (this includes details about your race or ethnicity, religious or philosophical beliefs, sex life, sexual orientation, political opinions, trade union membership, information about your health, and genetic and biometric data). Nor do we collect any information about criminal convictions and offences.



#### IF YOU FAIL TO PROVIDE PERSONAL DATA

Where we need to collect personal data by law, or under the terms of a contract we have with you, and you fail to provide that data when requested, we may not be able to perform the contract we have or are trying to enter into with you (for example, to provide you with a service). In this case, we may have to cancel a service you have with us, but we will notify you if this is the case at the time.

#### **HOW IS YOUR PERSONAL DATA COLLECTED?**

We use different methods to collect data from and about you including through:

#### DIRECT INTERACTIONS

You may give us your Identity, Contact and Marketing and Communications data by filling in forms or by corresponding with us by post, phone, email or otherwise. This includes personal data you provide when you:

- · Or your organisation or member firm contacts us directly;
- Provide us with your information at events or conferences;
- · Request marketing to be sent to you; or
- · Give us feedback or contact us.

#### REFERRALS FROM INTERLAW MEMBER FIRMS OR YOUR CLIENTS.

An organisation who is a member firm of the Interlaw network, or a client of yours, may provide us with your Identity and Contact data by corresponding with us by post, phone, email or otherwise.

#### AUTOMATED TECHNOLOGIES OR INTERACTIONS.

As you interact with our website, we will automatically collect Technical Data about your equipment, browsing actions and patterns. We collect this personal data by using cookies and other similar technologies.

#### • THIRD PARTIES OR PUBLICLY AVAILABLE SOURCES.

We will receive personal data about you from various third parties, such as via prospect lists provided by other organisations. We may also collect personal data via publicly available sources, such as your organisation's website.

#### **HOW WE USE YOUR PERSONAL DATA**

We will only use your personal data when the law allows us to. Most commonly, we will use your personal data in the following circumstances:

- · Where we need to perform the contract we are about to enter into or have entered into with you.
- Where you ask us to provide your contact details to an Interlaw member firm.
- Where it is necessary for our legitimate interests (or those of a third party) and your interests
  and fundamental rights do not override those interests. We do not use your personal data for
  activities where our interests are overridden by the impact on you (unless we have your consent or
  are otherwise required or permitted to by law). You can obtain further information about how we
  assess our legitimate interests against any potential impact on you in respect of specific activities
  by contacting us.
- Where we need to comply with a legal obligation.



Generally, we do not rely on consent as a legal basis for processing your personal data although we will get your consent before sending third party direct marketing communications to you via email or text message. You have the right to withdraw consent to marketing at any time by contacting us.

#### PURPOSES FOR WHICH WE WILL USE YOUR PERSONAL DATA

We have set out below, in a table format, a description of all the ways we plan to use your personal data, and which of the legal bases we rely on to do so. We have also identified what our legitimate interests are where appropriate.

Note that we may process your personal data for more than one lawful ground depending on the specific purpose for which we are using your data. Please contact us if you need details about the specific legal ground we are relying on to process your personal data where more than one ground has been set out in the table below.

We strive to provide you with choices regarding certain personal data uses, particularly around marketing and advertising.

# PROMOTIONAL OFFERS FROM US

We may use your Identity, Contact, Profile, Technical and Marketing and Communications data to form a view on what we think you may want or need, or what may be of interest to you.

## THIRD-PARTY MARKETING

We will get your express opt-in consent before we share your personal data with any third party for marketing purposes.

#### **OPTING OUT**

You can ask us or third parties to stop sending you marketing messages at any time by contacting us using the details provided in this privacy policy.

# **COOKIES**

You can set your browser to refuse all or some browser cookies, or to alert you when websites set or access cookies. If you disable or refuse cookies, please note that some parts of our website may become inaccessible or not function properly.



#### **CHANGE OF PURPOSE**

We will only use your personal data for the purposes for which we collected it, unless we reasonably consider that we need to use it for another reason and that reason is compatible with the original purpose. If you wish to get an explanation as to how the processing for the new purpose is compatible with the original purpose, please contact us.

If we need to use your personal data for an unrelated purpose, we will notify you and we will explain the legal basis which allows us to do so.

Please note that we may process your personal data without your knowledge or consent, in compliance with the above rules, where this is required or permitted by law.

#### DISCLOSURES OF YOUR PERSONAL DATA

We do not disclose any personal data with unrelated third parties, except for the following circumstances and in accordance with the purposes set out in the table above:

- INTERLAW MEMBER FIRMS: In order to provide you with the information or services requested, we may share your personal data or transfer it to Interlaw member firms.
- INTERLAW MEMBER GROUPS: If you have registered for access to the Interlaw Members' Portal
  on our website or joined an Interlaw member group, we may share your personal data with other
  members in Interlaw member groups.
- **EVENT ATTENDANCE:** If you attend an Interlaw event, we will share basic contact information or information necessary to secure travel/attendance arrangements with other event attendees.
- INTERLAW WEBSITE: If designated by your firm as an industry expert or person of contact, we will
  include your contact information on the Interlaw website.
- THIRD PARTY PROCESSORS: On occasion, we may transfer personal data to third party processors in accordance with the purposes set out in the table above. For example, a third party may have access to your Identity and Contact Data for purposes of event registration.

We require all third parties to respect the security of your personal data and to treat it in accordance with the law. We do not allow our third-party service providers to use your personal data for their own purposes and only permit them to process your personal data for specified purposes and in accordance with our instructions.

#### **INTERNATIONAL TRANSFERS**

Whenever we transfer your personal data out of the UK, we ensure a similar degree of protection is afforded to it by ensuring at least one of the following safeguards is implemented:

- We will only transfer your personal data to countries that have been deemed to provide an
  adequate level of protection for personal data.
- Where we use certain service providers, we may use specific contracts approved for use in the UK
  which give personal data the same protection it has in the UK.

Please contact us if you want further information on the specific mechanism used by us when transferring your personal data out of the UK.



#### **DATA SECURITY**

We have put in place appropriate security measures to prevent your personal data from being accidentally lost, used or accessed in an unauthorised way, altered or disclosed. In addition, we limit access to your personal data to those employees, agents, contractors and other third parties who have a business need to know. They will only process your personal data on our instructions and they are subject to a duty of confidentiality.

We have put in place procedures to deal with any suspected personal data breach and will notify you and any applicable regulator of a breach where we are legally required to do so.

#### **DATA RETENTION**

#### HOW LONG WILL YOU USE MY PERSONAL DATA FOR?

We will only retain your personal data for as long as reasonably necessary to fulfil the purposes we collected it for, including for the purposes of satisfying any legal, regulatory, tax, accounting or reporting requirements. We may retain your personal data for a longer period in the event of a complaint or if we reasonably believe there is a prospect of litigation in respect to our relationship with you.

To determine the appropriate retention period for personal data, we consider the amount, nature and sensitivity of the personal data, the potential risk of harm from unauthorised use or disclosure of your personal data, the purposes for which we process your personal data and whether we can achieve those purposes through other means, and the applicable legal, regulatory, tax, accounting or other requirements.

#### YOUR LEGAL RIGHTS

Under certain circumstances, you have rights under data protection laws in relation to your personal data, these include the right to:

- · Request access to your personal data.
- Request correction of your personal data.
- Request erasure of your personal data.
- Object to processing of your personal data.
- Request restriction of processing your personal data.
- Request transfer of your personal data.
- Right to withdraw consent.

If you wish to exercise any of the rights set out above, please contact us using the contact details provided.

#### **NO FEE USUALLY REQUIRED**

You will not have to pay a fee to access your personal data (or to exercise any of the other rights). However, we may charge a reasonable fee if your request is clearly unfounded, repetitive or excessive. Alternatively, we could refuse to comply with your request in these circumstances.
