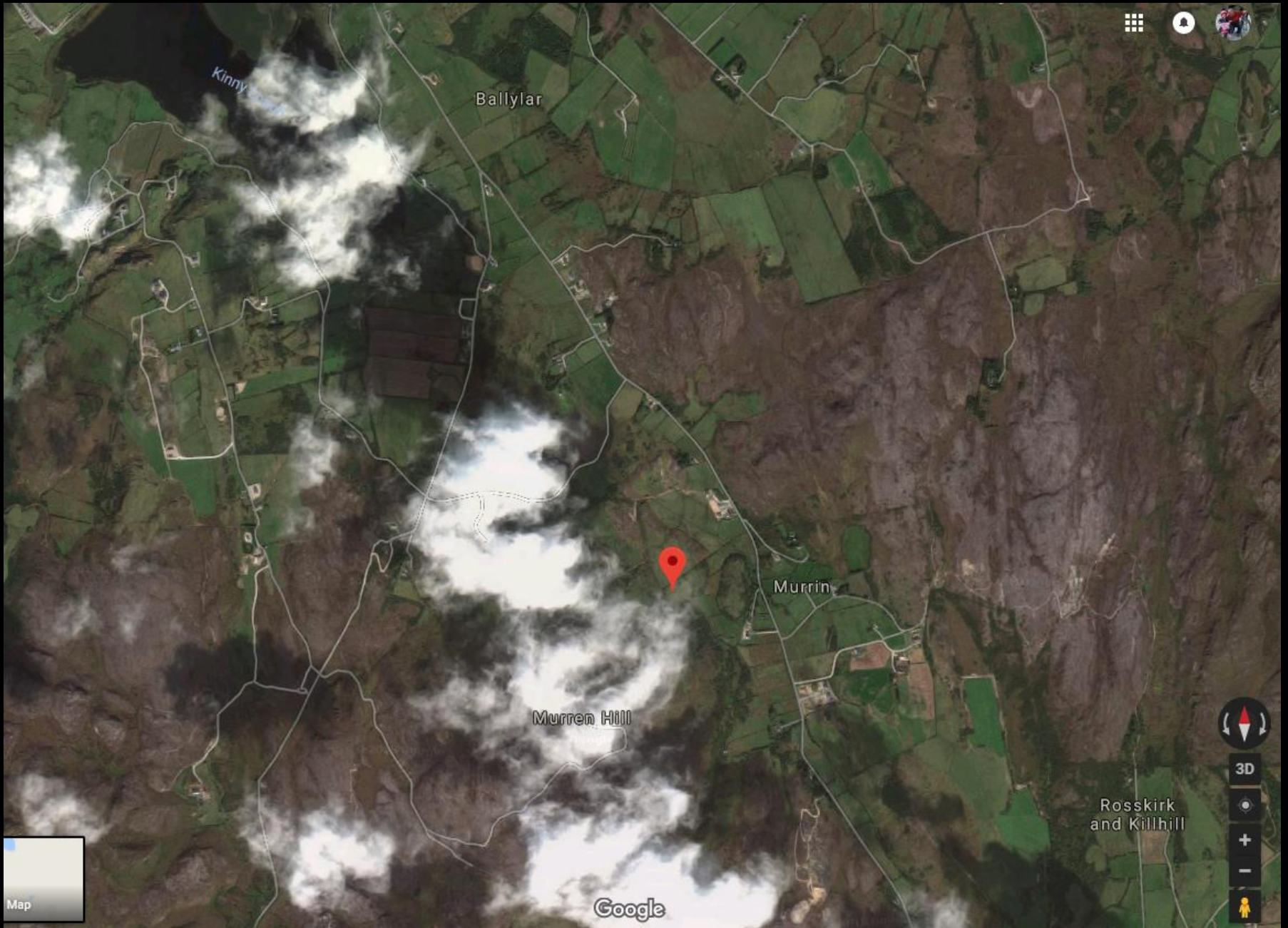

## 1830's Fanad:

Going back to the 1830's in there was a Tax collected throughout Fanad for the Church, this was a tax that was rolled out across the Island of Ireland.

Everyone who owned or leased land at the time had to pay and the Tithes that were collected were recorded in what is known as the Tithe Applotment Books.

In 1834 there were two Callaghan's recorded in the Tithe Applotment book as leasing land in the Townland of Murren.

There was a **William Callaghan** (my ancestor) and a **John Callaghan** in Murren

## 1850's Fanad:

In 1840's-1860's, there was a Primary Valuation of Lands carried out throughout the Country of Ireland. In 1858 it was done in the Parish of Clondavaddog (Fanad & Glenvar)

There was be two Callaghan's families recorded in the Townland of Murren.

**William Callaghan PLOT#2** which had 59 small acres of land and a medium size house.

**Michael Callaghan PLOT#5** who had 15 small acres of land.

He also shared a further 18 acres with Winifred Callaghan (possibly his mother) at **PLOTS 4a and 4b** with two medium/large size houses on them

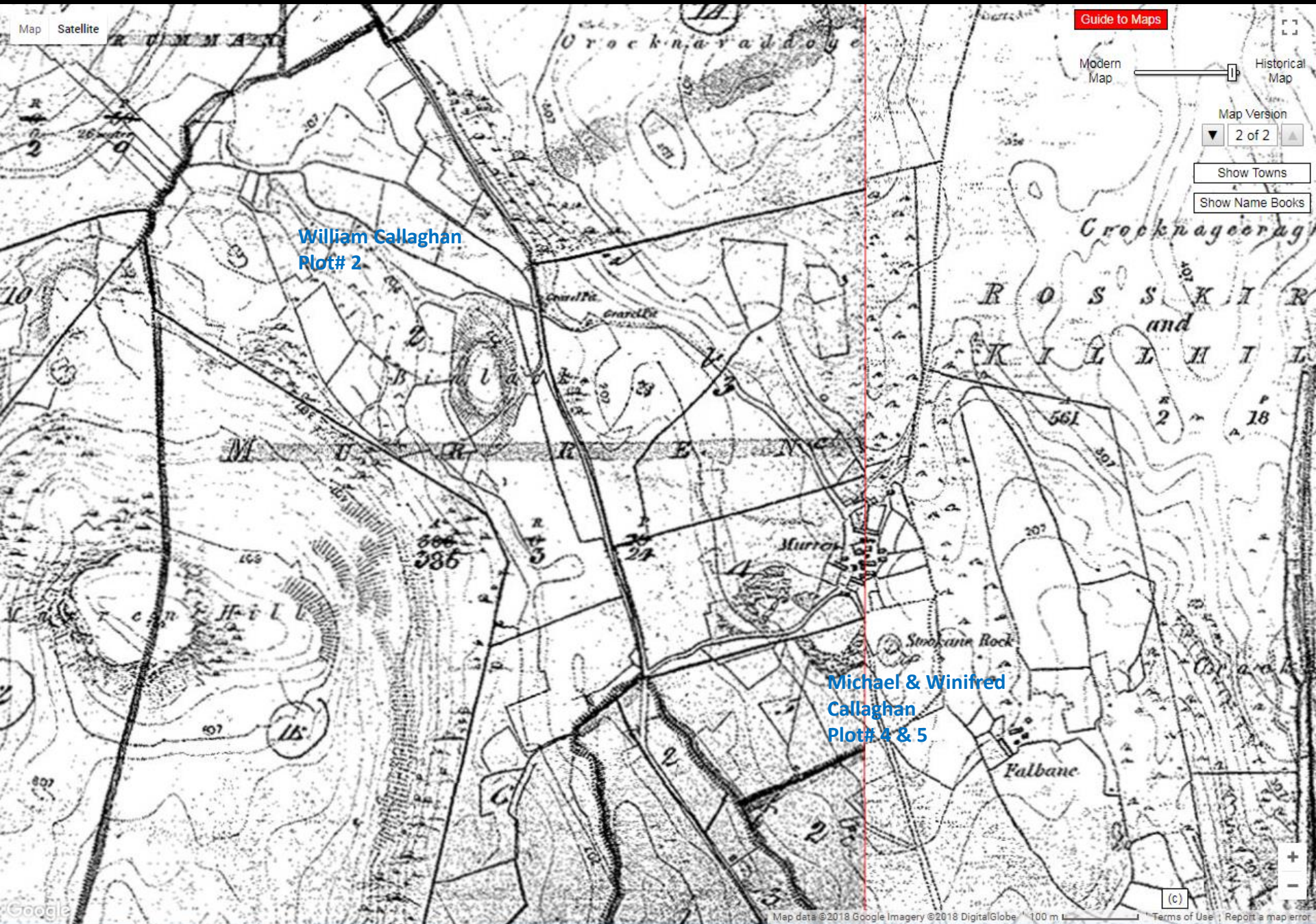
