This was particularly the case in major incidents where numerous items may be submitted, necessitating comprehensive notes and maintaining full evidential item-tracking for each piece of evidence.

With a focus on enhanced efficiency and accessibility, FSNI sought a modern, multi-functional software system. This system would serve as a centralized repository for information, providing a user-friendly interface for staff to access and update case-related data. By implementing such a system, FSNI aimed to address several other operational challenges, including streamlining operational tasks, managing staff workload more efficiently, and enhanced exhibit tracking.

- Efficient tracking of item movement through the system using bar codes.

- Facilitation of advanced business intelligence reporting.
- Full traceability of submitted items to FSNI, from reception at the laboratory.
