Discipline

**Appeals** Consisting of 3 governors (including 1 is a parent governor) with no prior knowledge of the incident

**Complaints** Any three governors with no prior knowledge of the incident

That the extent of financial delegation for expenditure and virements be as follows:

Up to £5,000 – Headteacher

£5,000 up to £10,000 – Headteacher and Chair

£10,000 up to £20,000 – Finance Committee

Over £20,000 – Full Governing Body

That the responsibility for the appointment of staff be delegated to the Headteacher plus one or more governors.
