Special Education Needs and Disabilities Policy and Local Offer

This policy was reviewed in February 2019

(Taking regard of the Children and Families Bill 2014)

It forms the basis of our “Local Offer” consisting of information for parents/carers of children who have Special Educational Needs (SEND) or a disability, and all of those who support children with additional needs. The information outlines the support and provision they can expect to receive whilst attending this school.

Consideration is also taken of the Single Equality Act 2010 and of the SEND Code of Practice 2014

Policy Statement

The Wing’s CE Trust Schools aim to enable pupils with special education needs and disabilities to be fully involved in the life of the school, and to reach their full potential, taking an active role in school life, feeling secure and happy whilst experiencing success in a caring and stimulating learning environment.

The schools also aim to involve pupils, their parents, staff and other concerned parties in the development of the necessary support for each child with special educational needs.

DEFINITION OF SPECIAL EDUCATIONAL NEEDS / DISABILITIES

A child or young person has SEND if they have a learning difficulty or disability which calls for special educational provision to be made for them.

A child of compulsory school age or a young person has a learning difficulty or disability if they:

- (a) have a significantly greater difficulty in learning than the majority of others of the same age; or
- (b) have a disability which prevents or hinders them from making use of educational facilities of a kind generally provided for others of the same age in mainstream schools.

A child under compulsory school age has special educational needs if they fall within the definition at (a) or (b) above or would so do if special educational provision was not made for them

(Clause 20 Children and Families Bill)

This is a broad definition covering children and young people from 0- 25 years of age. Where a child or young person has a disability or health condition which requires special educational provision to be made, they will be covered by the SEND definition.

OBJECTIVES

- To create an inclusive environment that meets the special educational needs of each child.
- To ensure that the special educational needs of children are identified, addressed and provided for.
- To make clear the expectations of all partners in the process (including parents and children)
- To identify the roles and responsibilities of staff in providing for children's educational needs.
- To enable all children to have full access to all elements of the school curriculum.
- To actively involve pupils in a SEND sensitive and non-stigmatising way in their learning to promote improved confidence and self-image.

ROLES AND RESPONSIBILITIES

The role of the Governing Board (ref: Children and Families Bill)

- To co-operate with the local authority in the development and review of the local offer. This is essential so that the local offer provides a comprehensive, transparent and accessible picture of the range of services available to local children and young people with SEND and their parents.
- To co-operate with the Head Teacher/SENDCO to determine the school's general policy and approach to provision for children with special educational needs.
- To establish appropriate staffing and funding arrangements.
- To maintain a general oversight of the work with Special Educational Needs pupils.

The role of the SENDCO

The key responsibilities of the SENDCO include:

- Overseeing the day-to-day leadership and operation of the SEND policy.
- To report back to the Head Teacher and Governing Board on a regular basis, giving updates of progress and development.
- Co-ordinating provision for children with Special Educational Needs.
- Liaising with the Head Teacher and other agencies.
- Liaising with and advising staff.
- Organising/ monitoring and evaluating interventions for children with Special Education needs.
- Overseeing the records of all children with Special Educational Needs.
- Liaising with parents of children with Special Educational Needs.
- Identifying needs and facilitating or contributing to the in-service training of staff.
- Liaising with external agencies including the Local Authority Access and Inclusion department; the Educational Psychology services; health and social services, and voluntary bodies.
- Working with the Head Teacher and school governors to ensure that the school meets its responsibilities under the Equality Act (2010) with regard to reasonable adjustments and access arrangements.

Appropriate time is given to the SENDCO in order for them to complete their workload and undertake any tasks.

The role of teaching and non-teaching staff

- To recognise that all teachers are teachers of SEND.
- To ensure that Quality First Teaching strategies are in place as part of the Graduated Approach to teaching children with SEND.
- To be involved in the development of the SEND policy.
- To be fully aware of the school's procedures for identifying, assessing and making provision for pupils with Special Educational Needs, including writing Pupil Passports along with class provision maps and reviewing and reporting progress to parents/carers.
- To provide appropriate and challenging activities for pupils with Special Educational Needs.
- To keep up to date records for children identified as having a special need, ensuring that CPOMS is used effectively.

ADMISSION ARRANGEMENTS

The Wing's CE Trust acknowledge their statutory duty to provide a mainstream school place for all pupils, regardless of their gender, ethnicity, religion, disability or special educational need, should their parents wish it and it is compatible with the efficient education of other pupils.

We recognise the intrinsic value of every child, and we aim to meet all pupil needs.
(Schedule 1 paragraph 4)

ACCESS TO THE CURRICULUM, INCLUDING THE NATIONAL CURRICULUM

All pupils follow the full National Curriculum, except where disapplication is clearly indicated, and this decision is fully supported by the Local Authority. All SEND pupils including those with an Education and Health Care Plan (EHCP) spend the majority of their time in mainstream classes following the same curriculum as their peers, differentiated where necessary. Pupils who need it are withdrawn for short periods for individual programmes based upon their targets. Care is taken to ensure that this enhances, and not disadvantages, pupils by this withdrawal. Staff ensure consideration is given to children with Special Educational Needs within their short term planning, and work is differentiated so that it is accessible to all children. This can be evidenced from planning and work produced by the children.

INCLUSION ARRANGEMENTS FOR PUPILS WITH SEND

All pupils play a full part in the life of the school. They have entitlement to all curricular and extra-curricular activities carried out at school. Those pupils who need individual interventions are withdrawn only for short periods.

FACILITIES

Educational access:

- The school employs a number of Teaching Assistants whose role includes the support of individuals or groups of children who need extra help in order to access the curriculum.
- The Teaching Assistants and Pastoral Team work closely with the class teachers and use recommendations of the children's targets, Individual Education or Behavioural Plans, in order to support learning and assist the children in reaching their targets.
- The school also provides nurturing interventions. The Pastoral Team have responsibility for these groups and work closely with the named person for safeguarding, extended services, and class teachers in identifying and supporting children who will benefit from a range of small group and/or 1:1 interventions.
- We also run a nurture room for each key stage supporting children who need smaller group work and a more nurturing style approach to learning. This may be a short term intervention or a more long term intervention.

Allocation of resources:

- The SENDCO, Head Teacher and Pastoral Team are responsible for the leadership of the resourcing for special needs provision within the school, including the provision for children with EYAR, EHCP or other special educational needs. Staff refer to the L.A. document 'Higher Expectations for All' for guidance.
- The Head Teacher informs the governing board of how the funding is allocated.
- The Head Teacher and the SENDCO meet on a regular basis to agree on how to use funds directly related to SEND.
- The school SENDCOs prepare a School Improvement Plan, which is monitored by the Governing Board and Head Teacher.

WORKING IN PARTNERSHIP WITH PARENTS

(Ref: Code of Practice: Chapter 2)

(Schedule 1 paragraph 15)

The Wings' CE Trust actively seek to work with parents to empower them to:

- Recognise and fulfil their responsibilities as parents and play an active and valued role in their child's education.
- Have knowledge of their child's entitlement within the SEND framework.
- Make their views known about how their child is educated.
- Have access to information, advice and support during assessment and any related decision making processes about special needs provision.

To enable this:

- Parents are informed at an early stage of any school concerns about their child through the Graduated Response system.
- Parents are encouraged to visit school and discuss any concerns or problems they may have about their child with the class teacher and/or the SENDCO.
- Parents are encouraged to be involved in SEND provision they may be part of, and to take an active role in developing Pupil Passports, Early Helps and Education Health Care Plans (E.H.C.P.).
- Parents are encouraged to take an active role in the monitoring their child's progress through regular review meetings.
- Problems and concerns are discussed and resolved through meetings with parent, pupil, class teacher, SENDCO, outside agencies and the L.A. The views and wishes of parents play an important part in these discussions and decisions.
- The school will inform parents of the Parent Partnership Services available within the Local authority
- School is aware that some parents will be anxious about their children needing SEND provision, and may find meetings with professional bodies stressful. We strive to make meetings parent friendly and convenient to all concerned.

PUPIL PARTICIPATION

Children, who are capable of forming views, have a right to receive and make known information, to express an opinion, and to have that opinion taken into account in any matters affecting them. The views of the child should be given due weight according to the age, maturity and capability of the child.

(Articles 12 and 13: The United Nations Convention on the Rights of the Child)

To enable this:

- We aim to give children the opportunity to discuss feelings and views with family and staff, and to contribute to the development of their Pupil Passport at an appropriate level.
- We aim to ensure that children are aware of their targets, if they have achieved them, or of the progress that they have made. Children, if possible, sign their Pupil Passport with their parents.
- Children celebrate their success through praise from staff, certificates, stickers, rewards, sharing their success with other children and teachers, thus raising self-esteem and their motivation to succeed.

- Children are given the opportunity to discuss concerns and problems, whether they be learning, social, emotional, behavioural or physical. They discuss why the problems occur, ways of avoiding them, how to resolve them and ways forward.
- The purpose of any assessment is explained to the child, to avoid any anxiety or confusion.
- The purpose of any visiting professional is explained to the child.
- School acknowledges the importance of providing therapeutic interventions for children.

EYFS: ASSESSMENT AND IDENTIFICATION

- Each Nursery setting has a designated Early Years SENDCO who works closely with the overall school SENDCO.
- Small Steps tracker is used in EYFS.
- ASQs are used in conjunction with parents for early identification of SEND.
- Teachers acknowledge that during the Foundation Stage, due to various previous learning and life experiences, also taking into account some children may not have received any education when they enter nursery or reception that children will progress at different rates. This may not necessarily mean they are children with SEND, but they will need carefully differentiated learning experiences and activities to ensure that they make satisfactory progress.
- On entering Reception, children are monitored using the Foundation Stage Assessment.

PRIMARY PHASE: ASSESSMENT AND IDENTIFICATION

- During both EYFS and the Key Stage One phase of education, teacher assessment and observation, along with parental views and contributions, will critically aid early identification of children with SEND
- At termly progress meetings, children requiring intervention are identified and appropriate interventions put in place.
- Across the school, assessment is undertaken using termly assessment and moderation.

GRADUATED RESPONSE

- The school's response is broken down into five major stages:
 - Monitoring through pupil progress meetings/ data
 - Interventions within and by school
 - School Support (assessments and/or Interventions by other support agencies)
 - School Support Plus
 - EHC Pathway for EHCP
(If a child has complex needs this may require an alternative specialist educational environment)
 - A child does not automatically progress through the stages. Intervention and stage of need may remain static if the child's progress is deemed to be satisfactory.
 - When a teacher is concerned about a child's progress they will arrange to speak to parents, and the SENDCO if appropriate.

Interventions

- When a class teacher or other educational practitioner, who works day to day with the child or the

SENDCO, identifies a child with special educational needs, they should devise interventions that are **additional to** or **different from** those provided as part of the settings usual curriculum offer and Quality First Teaching.

- Teachers, parents and where appropriate, the child, will develop a Pupil Passport. The SENDCO is available for help and advice on strategies and resources. The Pupil Passport identifies strengths and areas where support is needed.
- Class teachers will plan appropriate interventions each half term using a Class Provision Map with children and targets clearly identified.

School Support Plus

- If it is considered that the child has not made satisfactory progress then the SENDCO or Head Teacher will seek advice and support from outside agencies.
- Staff will arrange to meet the Wigan TESS team in an Individual Progress meeting to discuss next steps
- A referral may be made to the Educational Psychologist, who will carry out further assessments and give advice. Alternatively, a referral may be made to other agencies including OT, SALT, PT, Outreach and the school nurse. After initial meetings with one or more of these agencies, other specialists may be contacted to deal with the specific needs of individual children. Parents will continually be involved and kept informed of the steps the school is taking.

Statutory Assessment for EHCP:

- If, after several interventions have been developed, monitored and reviewed, the child has not made satisfactory progress, the school, after discussions with parents, and taking into account outside agencies advices and reports, will consider asking the Local Authority for a statutory assessment of the child.
- All reports from outside agencies, tracking data, reviews and any other relevant information are then sent to the Local Authority along with completed forms.
- If the Local Authority decides to proceed with statutory assessment, additional educational advice may be required of the school and this would be completed by the SENDCO and class teacher and returned as soon as possible.

Annual Reviews (ALL funded pupils are reviewed every twelve months)

- The SENDCO arranges the Annual Review, inviting any relevant outside agencies, parents and informs the Local Authority of the date, who may send a representative to the meeting.
- At the review meeting the child's progress is discussed in relation to the objectives listed in the EHCP (Education, Health and Care Plan).
- The school provision is discussed, such as equipment, resources and staffing, to ensure that the provision is appropriate and continues to meet the needs of the child.
- It is decided whether or not, the EHCP is still appropriate.
- If the EHCP remains in place, new targets may be set for the coming year.

EHCP

All staff involved will agree the action needed to help the child to progress in the light of the assessment, and if necessary additional advice from outside agencies. This may include:

- Different learning materials or special equipment.
- Some group or individual support (by Teacher, Teaching Assistant, Pastoral Team etc.)
- Extra adult time to devise the nature of the planned intervention and to monitor its effectiveness.
- Staff development and training to develop knowledge of problems and to introduce and deliver more effective strategies.
- Access to Local Authority support services for one-off or occasional advice on strategies or equipment.

PUPIL PASSPORTS AND CLASS PROVISION MAPS

- Each child who is at School Support Plus will have a one page Pupil Passport. Written by the class teacher, alongside the child, this will include important information about the child, their strengths, areas where support is needed, and how they can best be supported.
- These will be completed at the end of the summer term for transition to the new class and will be regularly reviewed throughout the following year.
- Alongside Pupil Passports, each class will have a Class Provision Map.
- The class Provision Map will detail any interventions that will take place with the children involved and their targets clearly identified.
- These will be reviewed each half term, with outcomes for each child listed, and a new one written.

TRANSITION OF PUPILS

- Meetings are arranged between staff during the summer term to discuss the transfer of children from one class to another within the school. Details of SEND are transferred to the new teacher, along with any relevant materials.
- 'Moving Up' time is allocated at the end of each year for the children to move to their new phase with their new teacher/pupils/room to undertake transitional work and set expectations for the following year whilst allowing pupils the opportunity to gain experience and 'settle in' for the coming year.
- Relevant SEND information is also passed on to the new class teacher via copies of reports and CPOMS.
- For children transferring between Key Stage Two and Key Stage Three, a meeting is arranged with the appropriate SENDCO of the school they are transferring to, to pass information.
- In the event of a supported transfer, either at this point or at any other point in the year, staff will attend the appropriate meeting to support that child's transfer to a new school, with the child, parents, staff from the new school, and any other involved parties.
- Children, who are funded, have a transition review, to which all involved parties are invited. (Parents, Local Authority officers, Health staff, Educational Psychologists, High school, SENDCO etc.)
- If a transfer plan is required, one is recommended and will be in place prior to the child's arrival in their High school.

MONITORING

- The SENDCO liaises with outside agencies.
- SENDCO meets regularly with the TESS teacher, Educational Psychologist and other professionals through the termly planning meeting.
- SENDCO meets regularly with Head Teacher and reports to the governing board.
- SENDCO regularly monitors SEND records.
- Head Teacher and where possible, the SENDCO attends each pupil progress meeting to flag up any child the teacher may be concerned about and discuss children already on the register to ensure they are making good progress.
- Notes from the meetings/monitoring are copied and given to staff.
- Copies of all Pupil Passport are uploaded to CPOMS central record.
- SENDCO attends reviews whenever possible, and always attends reviews of funded children.
- SENDCO file contains information on every child at Early Years Support/ School Support, Early Years Support Plus / School Support Plus and Education, Health and Care Plan.

- SENDCO attends L.A. SENDCO update meetings.

RESPONSE TO COMPLAINTS

Parents or children who are dissatisfied with any aspect of the special needs support offered should make their complaints:

- In the first instance to the Class Teacher
- Referred to the SENDCO
- Referred to the Head Teacher
- Referred to the CEO.
- If a parent is still unhappy, she/he can put her/his complaint in writing to the Chairperson of the Governing Board and follow the complaints procedure as indicated in the 'Complaints Policy'
- Further appeal can be made to the L.A. by contacting The Parent Partnership Office

Accessibility

Our schools are wheelchair accessible and have recently undergone building work to ensure it meets all required recommendations for accessibility.
