Dear Parent/Guardian,



Did you know that if you receive certain benefits then your child may be eligible for free school meals and, as a result, additional funding for school which can help us support you with things such as educational visits and new school uniform?

**We are looking to give out vouchers for £100 per child for families that successfully sign up to claim free school meals.**

If you are in receipt of:

- Universal Credit with an annual net earned income of no more than £7,400.
- Income Support
- Income-based Jobseeker's Allowance
- Income-related Employment and Support Allowance
- Support under Part 6 of the Immigration and Asylum Act 1999
- The guarantee element of Pension Credit
- Working Tax Credit run-on (paid for the four weeks after you stop qualifying for Working Tax Credit)
- Child Tax Credit (with no Working Tax Credit) with an annual income of no more than £16,190

Then you should be eligible for free school meals!

If you meet the criteria listed, **PLEASE** apply to register for free school meals by Friday 3<sup>rd</sup> April. Please sign up even if your child is currently in Reception, Year 1 or 2 as without the sign up, school will not receive the funding. You can also sign up even if you would prefer for your children to have a packed lunch!

If your application is successful, school will then receive additional funding for your child. This is used to enhance, enrich and support your child's individual learning experience and journey in a variety of ways, ranging from additional teaching staff for intervention and booster groups through to extra after school activities and clubs.

### **Stockingford Academy free school meals voucher**

This voucher is worth the value of £100 for pupils in receipt of free school meals.

It can be used throughout the school year for:

- Supporting school trips/educational visits
- School uniform/school shoes
- School bag
