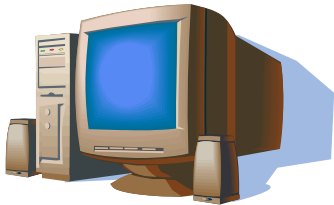

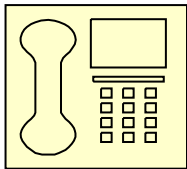

# **FACS**

## **Fair Access to Care Services.**

National tool applied locally to determine an individual's eligibility for adult social care provision.

In Coventry social care outcomes will be met if assessed as critical or substantial
