Dear Parent/Carer

IMPORTANT INFORMATION FOR ALL PARENT/CARERS

Webster Primary School has been working hard to improve the attendance of all pupils. It is widely recognised that the educational outcomes and future life chances of children and young people can be significantly impacted upon by periods of absence. Therefore we want to encourage parents to ensure that their child attends school every day. We do appreciate the fact that a significant number of pupils have excellent attendance and this should be commended.

At Webster Primary School we fully appreciate that there may be occasions when a pupil's attendance may be affected due to exceptional circumstances. In these cases support and advice will always be available from the school. Unfortunately, despite this support, attendance levels for some pupils continue to fall below the school's expectations of 97%. All pupils' attendance is closely monitored by the school and only the head teacher has the power to authorise any absence.

In the next school year which is from Monday 5th September 2016 until Friday 21st July 2017 any parents/carers of pupils who accrue unauthorised absence are now duly warned from the date of this letter that they may receive a penalty notice or be prosecuted in the magistrates court.

Where a parent/carer removes their child during term-time without authorisation they may be liable for a penalty notice or prosecution in the magistrates court.

A penalty notice will be issued to each parent for each child. The penalty notice incurs a fine of £120 to be paid within 28 days, which is reduced to £60 if paid within the first 21 days.

Failure to pay the penalty notice may result in legal proceedings being taken against you. Other statutory action may also be considered under the Education Act 1996, which may result in you being prosecuted in the Magistrates' Court. If you are found guilty, you will receive a criminal record and may receive a fine of up to £2,500 and/or three months' imprisonment.

If your child is missing from school without authorisation for more than 10 days, your child could be taken off roll and you may lose your school place. This is subject to the Local Authority guidelines.

If your child is experiencing any problems that may be affecting their attendance or punctuality, then please contact the school on 0161 226 3928 to discuss any support that could be provided to ensure their regular attendance. **We would also request parents/carers provide school with medical evidence when absence is related to illness, ie. a copy of prescriptions or medical/appointment cards.**

Once again thank you for supporting Webster Primary School in improving attendance, which will ensure that all pupils in school have the opportunity to reach their full potential and improve outcomes for their future.

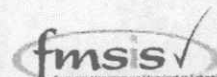
