**Uniform Policy**

**Rights Respecting School**

Vane Road Primary School is working towards being a Rights Respecting School where we adhere to the United Nations Convention on the Rights of the Child. By promoting and implementing our Uniform Policy, we believe that we can further provide opportunities for our children's right to an education (Article 28).

Vane Road Primary School believes that the appearance of the members of its community is important. Young people come to school not merely for academic input but also to absorb an ethos and culture which is reflected in the code of conduct, general behaviour and expectations.

**Aims**

Our policy for school uniform is based on the notion that school uniform:

- Promotes a sense of pride in the school
- Engenders a sense of community and belonging towards the school
- Is practical and smart
- Makes children feel equal to their peers in terms of appearance
- Is regarded as suitable wear for school and is considered by parents as good value for money
- Is designed with health and safety in mind

The school uniform is:

*a grey skirt, trousers or pinafore, maroon cardigan, pullover or sweatshirt and a white blouse/shirt or white polo shirt.*

*All children are to wear black school shoes. Boots are permitted but must be all black, plain and below the knee.*

*Please note that neither track suit bottoms nor trainers are appropriate.*

*For safety reasons we ask that pupils **do not** wear sling back sandals or shoes with platform wedges or high heels.*

Please ensure that all children's clothes are marked with their name.

**School Stock**

In the case that a child arrives at school without their school uniform on the school will provide the child with a clean uniform to wear for that day.

Refusal to co-operate with this would be dealt with under the terms of the School's Behaviour and Discipline policy.

### **Other Clothing Needs**

Children will require plain black shorts and white T-shirts for P.E. Children have bare feet or plimsols for indoor PE. Children will need trainers for outdoor games. Tracksuits may be worn during the colder weather.

For reasons of hygiene, children should not arrive at school in P.E. wear, but should be able to change for lessons. PE clothes should be kept in a bag which will be hung on a peg.

### **Footwear**

The school wants all children to grow into healthy adults. We believe that it is dangerous for children to wear shoes that have platform soles or high heels and so these are not permitted in school. Neither is it in keeping with the smart appearance of a school uniform.

### **Jewellery**

No item of jewellery other than wrist watches should be worn for school. Our no jewellery policy is in the interests of your child's safety.

### **Makeup**

The wearing of makeup is not permitted for children in the school. This includes nail varnish and false tan.

Tattoos should also be removed before coming to school.

### **Hair**

Children are encouraged to have their hair well brushed and clean for each day. Haircut should be even and of their natural colour. That is to say that lines, patterns and 'tails' are not appropriate for school. All hair which is long should be tied up. This is to prevent the spread of head lice.

### **The Role of Parents**

We ask all parents who send their children to our school to support the school uniform policy. It is the responsibility of parents to ensure that their child has the correct uniform and that it is clean and in good repair.

### **The Role of Governors**

It is the governors' responsibility to ensure that the school uniform meets all the regulations concerning equal opportunities. The governors will consider, with the Headteacher, any requests from parents for individual children to have special dispensation, either for religious or medical reasons, with regard to school uniform.

On a day to day basis the Head teacher has the final say in any uncertainties that may arise.

This policy, which has been endorsed by the Governing Body, will be reviewed every 3 years.
