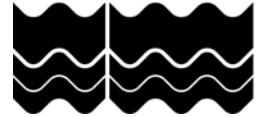


# Application for free school meals (FM1)



Please complete this form in BLOCK CAPITALS once you have read the notes overleaf to see what evidence you may need to provide before free school meals can be granted.

Once the form has been filled in, simply return it to one of the schools your child(ren) attends with proof of eligibility so they can authorise free school meals. Alternatively, you can send your application form c/o the Free Meals Team to the address given overleaf.

## Proof of benefit

If the electronic checking service has not been able to verify your application you can supply paper evidence as an alternative. Proof that you receive at least one of the following benefits will be required.

### Income Support/Job Seekers Allowance (income based)/Employment & Support Allowance (income related)

If you receive Income Support, Job Seekers Allowance (income based) or Employment and Support Allowance (income related) you can have the section below completed and **stamped** by Job Centre Plus as proof of eligibility. As an alternative, you will need to show the school a letter **dated within the last three months** detailing current receipt of one of the these benefits.

### Child Tax Credit (without Working Tax Credit)

If you receive Child Tax Credit and your income does not exceed the qualifying amount. The qualifying amount changes each financial year. The threshold for 2010/2011 is £16,190. Please note that free school meals cannot be granted **if you receive any amount of Working Tax Credit**. You will need to show the school your original Tax Credit award notice (TC602) for the current tax year.

### Pension Credit – guarantee credit

If you receive Pension Credit – guarantee credit. You will need to show the school your current award notice. A Pension Credit payment book cannot be accepted as proof of entitlement.

### Immigration and Asylum Act 1999

If you receive financial support under Part 6 of the Immigration and Asylum Act 1999. You will need to provide the school with a letter from NASS (National Asylum Support Service) to confirm you are receiving support.
