### Governance – The Governing Body

The Governing Body delegates the day-to-day responsibility to the Head Teacher, for ensuring financial controls conform with the requirements of both propriety and good financial management and in accordance with the requirements and responsibilities assigned to it in the Funding Agreement between Barby School (as part of the Peterborough Diocese Education Trust) and the Secretary of State for Education.
