### **CONSULTATION ON SCHOOL DATES** **2018-2019**



OVAL Learning Trust is consulting on school term dates and holiday patterns for the academic year 2018/19. This is due to local variation in dates for both the October half-term (2018) and the Easter break (2019). Trustees and Local Governors feel that it is vital to consult with stakeholders before any decisions are made, as we understand that changing, or not changing, the term dates will have consequences for both parents and staff. Completing the information below will, therefore, help inform the process.

Schools in the OVAL Learning Trust have always found that the Leicestershire LA holiday pattern has been an effective one to follow – for both staff and pupils – and we would not have chosen to initiate a consultation to move away from this. However, as there have been some local changes (especially with our feeder secondary schools), we feel it is essential to openly invite your views on the matter. It is really important, therefore, that we get as many responses as possible to help us understand the strength of feeling amongst our stakeholders regarding either changing the holiday pattern or remaining aligned with the Leicestershire LA dates. Please do include your reasoning on the response, as this will be helpful to the decision-making process.

Please tick to show your preferred option for each holiday or indicate to show you have no preference. We are closing the consultation after the October half-term this year to enable you to better consider the impact of any move away from the Leicestershire LA pattern. All of our schools are in the Ashby/Coalville family and so the dates proposed by local secondary schools are included for reference.
