

## Jump Nursery – Early Years Pupil Premium September 2017

### **Background**

The Early Years Pupil Premium is a Government initiative that targets extra money at 3yr old and 4yr old pupils from disadvantaged backgrounds, which research shows, underachieve compared to their peers. The premium is provided to improve the quality of education for these pupils.

### **Provision**

Jump Primary School Governing Body will ensure that provision is made which secures all teaching and learning opportunities meet the needs of all children.

### **Reporting**

The Headteacher will report to the Attainment and Achievement Committee each term on:

- The progress made by all groups of pupils including those who qualify for Early Years Pupil Premium Funding
- The provision that was made during the term
- An evaluation of cost effectiveness

### **Success Criteria**

The evaluation of this policy will be based on the tracking of identified target groups of children. Data analysis and, due to the age of the children, CSA and teacher observation, will be used to evaluate the effectiveness of interventions and experiences provided. These interventions and experiences have been identified by the class teacher and CSA, and action plans written accordingly. These include:

- Clear baseline testing, data collection and analysis
- Early intervention and support
- Individual targets
- The sharing of information with parents
- A positive culture which recognises pupils' differences
- A recognition that all children are able to achieve

### **How much Early Years Pupil Premium does Jump Nursery receive?**

From September 2017 1 nursery child is recorded as being eligible for EYPP.

Our Early Years Pupil Premium allocation from April 2017 was £903 (53p per hour per child).

### **How does Jump Nursery use this additional funding?**

### **What needs do our group of EYPP children have?**

Currently there is 1 girl in Jump Nursery who is eligible for the EYPP.
