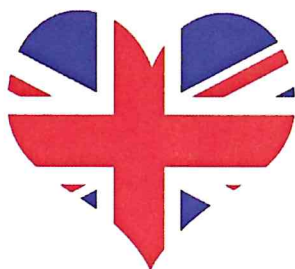

Breakfast Club

Due to rising costs we have no alternative but to increase the breakfast club payment from £2 to £2.50 per day. This will take effect from September 2018. The cost of Breakfast Club has not increased since it commenced over 10 years ago and we feel still represents excellent value for money.

General Data Protection Regulation 2018

On 25th May 2018 the General Data Protection Regulation (GDPR) will replace the Data Protection Act 1998.

The GDPR is similar to the Data Protection Act (DPA) (which schools already comply with), but strengthens many of the DPA's principles. The main changes are:

- Schools must appoint a data protection officer, who will advise on compliance with the GDPR and other relevant data protection law
- Privacy notices must be in clear and plain language and include some extra information – the school's 'legal basis' for processing, the individual's rights in relation to their own data
- Schools will only have a month to comply with subject access requests, and in most cases can't charge
- Where the school needs an individual's consent to process data, this consent must be freely given and specific.
- There are new, special protections for children's data
- Schools will have to demonstrate how they comply with the new law.

In order for us to comply with this new legislation you will be receiving various forms which you will be asked to complete. Whilst I know you have already supplied us with this information, we would be grateful if you would assist us in completing the new forms. We have also created an area on our website which holds all the information you need regarding GDPR, this includes all relevant policies, privacy notice for pupils and blank forms for you to print and complete.
