

SAFEGUARDING CHILDREN

Our schools are committed to safeguarding and promoting the welfare of children and expect all staff and volunteers to share this commitment.

- This means that we have a Child Protection and Safeguarding Policy and Procedures in place which we refer to in our prospectus and on the website.
- All staff (including supply staff, volunteers and Governors) must ensure that they are aware of these procedures. Parents and carers are welcome to read the policy on request.
- Sometimes we may need to share information and work in partnership
 with other agencies when there are concerns about a child's welfare. We
 will ensure that our concerns about our pupils are discussed with their
 parents/carers first unless we have reason to believe that such a move
 would be contrary to the child's welfare.
- If you are concerned about a child's welfare, please record your concern, and any observations or conversation heard, and report to one of the DSLs as soon as possible. Do NOT conduct your own investigation.
- If your concerns relate to the actions or behaviour of a member of staff (which could suggest that she/he is unsuitable to work with children) then you should report this to one of the DSLs in confidence, who will refer the matter to the Executive Head Teacher (or the Chair of Governors if the concern relates to the Executive Head Teacher) who will consider what action to take.

Safeguarding General Points:

- At all times when you enter or leave the schools, please ensure that the gates to the schools are closed.

- Log any head injuries in the Accident Report Book and fill out a head injury form so that the class teacher can be notified.
- If you are injured at work, please fill out an accident report.
- Help the children to move safely around the school at all times.
