14. <u>Academisation Update</u>

MS - we are currently exploring the possibilities for us – we are researching and fact finding with other local schools – there is a further meeting tomorrow 05/10/2016 and schools will be declaring their decisions about exploring the academy route - we will need to make a decision before the end of the year as to whether we are going to go down the academy route.

LH – asked about the pros and cons of primary schools going down the academy route her own experience in secondary education hadn't been too good.

SS – Should have more flexibility as an academy

MS to send out academisation information to all governors.

Discussion on how joining with other local schools will effect Minworth and the advantages of this.

CEO would be responsible for the standards of performance for all the schools in the group.

PC – there will be positive funding implications.

Staff would have to be TUPEd over to protect their contracts.

15. Parent Matters

Ofsted have Parent View (online survey)— not being used — which is why we use our paper process to address any concerns that parents raise. Very positive feedback from parents.

16. Policies

KS reported on the Phonics Policy changes that have been made to the new rewritten policy – 6 phases of mixed groups. Assessed half termly.

Governors unanimously agreed to adopt the Phonics Policy and agreed to the school's approach to implementing new/changes to polices.
