



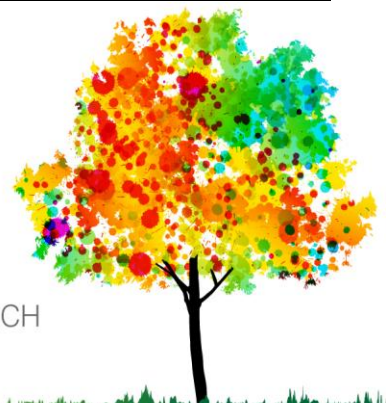
Permissions 2018/2019

As you may be aware, the General Data Protection Regulations (GDPR) came into force on 25th May, 2018 and sets out principles for how we process people’s personal data and keep it safe. The school is allowed to have access to, use and share certain personal information as part of its legal responsibilities, however, in some cases we must obtain additional consent.

The permission slips below will cover a year of your child’s time at Palterton Primary School. Each year we will ask for your permission. If in the future you wish to change any of the authorisations, please ask for another of these forms.

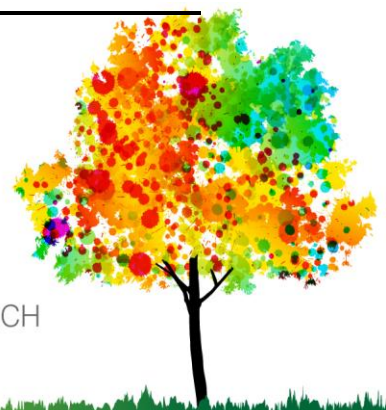

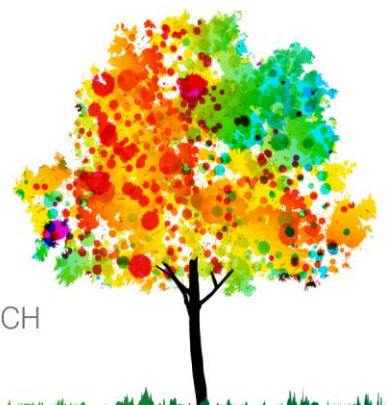
Assemblies and School Activities
