Improve the outcomes for PPG children in reading, improving the progress for PPG children and the more able.	Progress of PPG children by the end of Key Stage 2 compares favourably with other pupils nationally including those that are more able.
The aspirations, confidence and self-belief of pupils identified as eligible will improve and increase as evidence in increased contributions within the classroom, pupil and parental feedback.	Progress of PPG children by the end of Key Stage 2 compares favourably with other pupils nationally including those that are more able.
Children who are eligible for PP who have additional SEN, will make progress in line with other groups and compared to similar pupils nationally	SEN pupils eligible for PP will compare favourably with other pupils nationally. Academic interventions will be in place throughout the school, to support in diminishing the difference in core areas, so that SEN pupils eligible for PP make the same progress as other groups. External advisors/teachers/consultants will be brought into school to support pupil when appropriate. (TESS team, Educational Psychologists, Speech and Language)
