



## **Żar Tanga Marathon MIX** **16-19.04.2026**

### **Regulations**

1. The tango marathon is a closed event, available only to registered participants who appear on the participant list prepared by the Organizers.
2. Registration for the marathon can only be completed via the form available at [www.relaksmiedzybrodzie.pl/zartanga](http://www.relaksmiedzybrodzie.pl/zartanga). Registration opens on October 18, 2025, at 14:00 (Polish time) and will continue until all spots are filled.
3. After submitting the registration form, an automatic confirmation email will be sent to the address provided in the form (please ensure it is entered correctly). This is not yet a confirmation of acceptance to the marathon. Please refrain from making travel arrangements or booking accommodation until you receive final confirmation of participation after payment.
4. The Organizer reserves the right to decide on acceptance, taking into account the balance between leaders and followers.
5. The Organizer will inform you of acceptance to the marathon or placement on the waiting list within 4 days of receiving the registration form, using the email address provided.
6. Together with the confirmation of acceptance, you will receive the bank account number to which the deposit should be paid – PLN 450 for participants with accommodation, or PLN 200 for participants without accommodation – within 7 days. The remaining amount is to be paid on the first day of the event, in cash or by card at the venue. In the payment title, simply include your full name.
7. Once the payment has been credited, the Organizer will send the final confirmation of participation electronically.
8. In case of withdrawal from the event up to 3 months before it begins (by January 16, 2026), the Organizer will refund 70% of the paid deposit.
9. Transferring a payment and reservation to another participant is possible only with the Organizer's consent.
10. The Organizer decides on the acceptance of the next person from the waiting list.
11. Participation in the marathon constitutes consent for the Organizer to use your image and likeness for marketing purposes.

**Information Clause**
