Introduction

This guide looks to assist businesses that have relocated or are in the process of relocating to the Isle of Man. Relocating or setting up a business in a new country can be an exceptionally stressful time; you will need to consider business premises, work permits and visas for your staff, while also taking into consideration a number of financial and legal obligations. Here at Locate Isle of Man we have prepared this one-stop guide for what you need to know about relocating your business to this exceptional Island.

Where is the Isle of Man?

The Isle of Man occupies a central position in the Irish Sea and the British Isles - between England and Ireland.

What's it like?

The Island is blessed with an extensive coastline, stunning natural landscapes and unspoilt beaches, and is a popular holiday destination. Measuring 33 miles long and 13 miles wide, with a population of over 80,000 people, the Island has a diverse landscape, including glens, forests and beaches – and enjoys temperate weather all year round.

The Isle of Man is a self-governing country, but has always had, and continues to have, very strong ties to the UK. The Island has exceptional public services and a highly advanced technical infrastructure. It offers excellent educational facilities and an NHS style free healthcare system.

The Island is a vibrant business centre, and has extensive job opportunities across a range of dynamic and exciting industries, spanning financial services, i-gaming, aerospace, ICT, manufacturing and food and drink. On average salaries are higher than in the UK and Isle of Man residents enjoy some of the lowest tax rates in Europe with a simple and efficient calculation system. There is also no capital gains tax, inheritance tax or stamp duty land tax in the Isle of Man.

The Island has a strong national Manx identity and culture that is community spirited and celebrated with unique cultural, food and drink and sporting festivals throughout the year including the world renowned TT races, Yn Chruinnaght and the Parish Walk.

Those living in the Island benefit from an unbeatable quality of life and great lifestyle opportunities. The Island is one of the safest places to live in Europe and is the first Island Nation in the world to be awarded UNESCO Biosphere status, making it a truly unique location to live and work.

Why start your business in the Isle of Man?

The Isle of Man is a leading international business centre renowned for its innovation, professionalism and long-standing policy of positive engagement with international initiatives and standards. There are many reasons to start your business in the Isle of Man, these include:

- Stable government and economy
- Corporate income tax set at 0% for most businesses
- Double tax treaty with the UK
- Common customs/VAT area with the UK
- No withholding tax on interest or dividends
- Supportive Government with close relationships to the private sector
- Pragmatic regulation and consumer protection
- Solid infrastructure for transport and technology
- Financial support, including loans, grants and key employee incentives

Financial and Legal Considerations

Registering your business

Most Isle of Man companies are formed under the Companies Act 1931, the Companies Act 2006, or the Limited Liability Companies Act 1996. Depending on what you are aiming to use the company for, each Act has a variety of advantages and disadvantages to consider.

When relocating, your legal options include either incorporating as a new company in the Isle of Man, or establishing a branch of your existing company.

Registering a company in the Isle of Man is simple and straightforward, however we would recommend speaking to an Isle of Man Accountant, Corporate Service Provider (company secretarial and administration services who are licenced by the Financial Services Authority to undertake such work) or an Advocate to discuss your options.

An Isle of Man company must have a registered office in the Isle of Man and anyone providing a registered office by way of business should be regulated by the Financial Services Authority ('FSA'). The FSA is the primary regulator of financial services business in the Isle of Man and provides a framework of regulation and oversight which satisfies international standards. Taxation

Corporate

The Isle of Man offers plenty of tax benefits including no capital gains, 0% corporate income tax for most businesses, and no inheritance tax

All businesses will have to file an annual corporate income tax return online.

VAT & Customs

The VAT registration limit in the Isle of Man is £90,000 per annum and this is taken over a rolling period of 12 months, not just over your financial year.

Income Tax Instalment Payments (ITIP)

In the Isle of Man, ITIP covers everyone who receives remuneration and includes employees and office holders such as directors. Any remuneration is subject to ITIP and tax should be deducted in accordance with the employee's tax code.

If you employ one or more individuals you have to notify the Income Tax Division no later than 14 days from the point at which you begin to pay remuneration to your employee(s). You can do this by completing an Employer's Registration Form (a T30i), which is for private employers and sole traders, a T30x for partnerships, a T30c for Limited Companies or T30p for pension providers.

ITIP Free Pay, Standard Band and Higher Rate tax tables can be found on the [Isle of Man Government website](#).

Personal

For a single person in the Isle of Man, your first £17,000 per annum is completely tax free. The next £6,500 is taxed at the standard rate of 10%. Any income above £23,500 is taxed at the higher rate of 21%.

The Island also offers a Tax Cap for new and existing resident individuals of £220,000 per annum, specifically introduced for those who have annual income such that their tax liability would otherwise exceed the Tax Cap. Individuals who are resident in the Isle of Man for income tax purposes are able to benefit from the Tax Cap, and the maximum liability for a jointly assessed couple under the Tax Cap is £440,000.

This Tax Cap can be elected for a 5 or 10-year period, and once elected, the cap remains fixed for the duration of that period.

Individuals can apply to confirm whether they are eligible to benefit from the tax cap.

All new residents should complete form R25 Registration for Manx Income Tax as soon as possible after moving to the Island and will be required to complete an annual personal income tax return.

Non-residents receiving Isle of Man source income, for example, rent or pension payments, will be required to complete an income tax return.

Vehicle Tax/Licence Fee

To drive a vehicle on Isle of Man public roads, your car will require taxing, also known as the 'Vehicle Licence Fee'.

Property Taxes

There are no restrictions on purchasing property in the Isle of Man, no stamp duty and no inheritance tax, so you can start searching for your ideal office space today.

Intellectual Property Rights

For any business with patents, copyright and trademarks, intellectual property rights are of huge importance and the Isle of Man has strong intellectual property treaties to protect the Island's vast business community.

When relocating your business, it's important to consider the legal implications to any intellectual property you currently own or have rights to. You can instruct a local law firm to assist with the transfer of any intellectual property to an operating entity in the Isle of Man.

If you are based in the Isle of Man and wish to register a trade mark, patent or copyright you will need to contact the UK Intellectual Property Office.

Ship & Aircraft Registration

The Isle of Man Aircraft Registry is specifically aimed at private and corporate business jets and helicopters. There are many benefits to registering your corporate aircraft in the Isle of Man, including the neutral nationality registration prefix 'M' which allows your aircraft to fly worldwide without constraint.

IMMIGRATION

Work Permits

Who Needs to Apply?

Anyone who is not classed as an Isle of Man worker requires a work permit to take up employment (including self-employment) in the Isle of Man.

Could I be Exempt?

Exempt Occupations

There are exemptions for a number of occupations and employments, and for certain temporary employments.

Outside of the UK and Ireland

Nationals from outside of the UK and Ireland who have an immigration employment document do not require permits.

The Application Process

When applying for a work permit, an application can be made by:

- an employer;
- a self-employed person;
- the spouse/civil/co-habiting partner of an Isle of Man worker. (This permit must be renewed annually at a cost of £60).

The fee for a work permit is £60 and can be applied for up to five years.

If you are an employer you will need to complete the **Application for a Work Permit for Employment** form.

If you are self-employed, you will need to complete the **Application for a Work Permit for Self-employment** form.

You should expect to have your application processed within ten working days, however, it is often processed quicker than this.

The Work Permit Office will issue a decision for every work permit application. If they decide:

- to refuse to grant or renew a permit; or
- to grant or renew a permit for a shorter period than that applied for; or
- to include a condition in a permit

It will include a statement of the reasons for the decision and information about how an appeal to the Work Permit Appeal Tribunal can be made. Written notice of an appeal can be given to the Tribunal Clerk within seven days of the initial decision.

Partners

The following are (upon application) entitled to an automatic permit -

- The spouse, civil partner or cohabiting partner of a work permit holder or an exempt person, provided that the work permit holder or exempt person is in permanent, full-time employment.
- The cohabiting partner of an Isle of Man worker.

Renewing a Permit

If the employment is to continue past the date of expiry of the work permit, an application to renew a permit is needed. Usually you won't have to complete a new application; the original permit includes a renewal slip which can be sent to the Work Permit Office. In most cases this will also be handled by the employer.

If an employee ceases working for you

If a permit holder ceases work, the Work Permit Office has to be notified within 14 days.



Visas and Immigration in the Isle of Man

The Isle of Man is a Crown Dependency and as such, is entitled to, and uses the services of British Embassies, Visa Application Centres and other diplomatic offices around the world for immigration.

Individuals moving from the UK and Ireland do not require a visa. For those who do require a visa, the application process is simple and straightforward.

Applicants must apply online from their country of residence for Entry Clearance for the Isle of Man. The British Embassy will, after some initial processes, then refer the visa application to the Isle of Man Immigration Service for a decision.

While immigration rules are very similar to the UK, they are not identical, so it is important that you understand the process.

Below we've outlined the main visa types that allow individuals to work, settle, and invest in the Isle of Man.

For Businesses

There are two routes to establishing your business in the Island depending on your circumstances. All applications must be endorsed by the Department for Enterprise before the immigration process begins.

The Business Migrant - Start-up

This route is for migrants seeking to establish an innovative, viable and scalable business. Whilst there is no minimum investment requirement you will need to demonstrate that you have sufficient funding to establish the business and support yourself and any dependants.

This category offers leave for two years and four months and does not lead to indefinite leave to remain. To achieve indefinite leave to remain, migrants may progress to the Innovator route.

Once you have endorsement from the Department, you can apply for a visa online by following the process outlined on [Isle of Man Government website](#).

The Department for Enterprise will maintain regular contact every six months with the migrant to ensure reasonable progress is being made.

The Business Migrant - Innovator

This route is for migrants with business experience seeking to establish, join or take over one or more businesses in the Isle of Man. Unless progressing from the Start-Up route, migrants must have a minimum of £50,000 to invest in the business.

Migrants seeking to establish a new business under this subcategory will have an innovative, viable and scalable business idea. Migrants seeking to join, or take over an existing business or businesses, will be required to demonstrate how the investment will be made and the migrant's plans for the business.

This category leads to indefinite leave to remain. Once you have endorsement from the Department, you can apply for a visa online by following the process outlined on the [Isle of Man Government website](#).

The Department for Enterprise will maintain regular contact every six months with the migrant to ensure reasonable progress is being made.

Application Fees:

All Business Migrants must obtain a Letter of Endorsement from the Department before making a visa application under the Business Migrant Route. The fee to apply for a Letter of Endorsement is £1,000 GBP (all bank fees and charges must be paid by the Applicant).

For Workers

There are five routes which permit individuals to work in the Isle of Man, including: Isle of Man Worker Migrant visa, Isle of Man Worker Intra-Company Transfer (ICT) Migrant visa, Worker Migrant Health and Care visa, Tier 5 - Temporary Workers visa and Tier 5 - Youth Mobility Scheme visa (Temporary Migrants).

For Settlers

There are five main routes you can apply under if you would like to settle in the Isle of Man. These include clearance as a spouse, civil partner, fiancé or family member.

Other settlement visas include 'dependant', 'relative who'll provide long-term care', and 'Isle of Man/UK Ancestry'.

If you have Isle of Man ancestry, you may already qualify as an Isle of Man worker, and thus may not require a work permit as well.

If you are looking to apply for a settlement visa you must do so from outside the Isle of Man and UK. To apply, visit the UK Visas and Immigration website.

Naturalisation and registration as a British Citizen

You can apply for citizenship if you are over 18 and have one of the following for 12 months: Indefinite leave to remain in the UK or Isle of Man, 'settled status' (also known as 'indefinite leave to remain under the EU Settlement Scheme'), indefinite leave to enter the UK or Isle of Man (permission to move to the UK permanently from abroad).

Common Travel Area

The Isle of Man, United Kingdom, Channel Islands and the Republic of Ireland collectively form a 'common travel area'. This means that an applicant who has entered the common travel area and who has been through immigration does not require 'leave to enter' to visit any other part of the common travel area.

To put this simply, travel between the Isle of Man and the United Kingdom is an internal domestic journey, so there is no separate immigration needed.

Other

The Isle of Man Job Centre website compiles live job vacancies from across the Island. You can list your job directly on the website for free to help generate applications.

The Job Centre is based centrally in the Island's capital Douglas.

IOM today is the Isle of Man newspapers online media platform. Employers have the option to post job advertisements both on online and in the traditional press. The Island has three weekly newspapers, all with a jobs classified section.

Just the Job has been designed to help young people (between 14 and 25) unlock career opportunities on the Isle of Man and to connect with local employers. This includes permanent and part-time roles, graduate posts, seasonal work, apprenticeships, internships and volunteering opportunities.

The Talent Portal is free to use for organisations, recruitment agencies and individual workers. The portal is an online networking site which can help you connect with candidates who have the skills you need.

Transport

Transporting your possessions, vehicles and pets also needs to be considered. The Isle of Man Steam Packet makes moving your things a lot easier and cheaper. You can arrange for larger transport vehicles and vans to transport your belongings. Most pets can be taken on-board too!

The Isle of Man Ferry is a great option if you are moving from the UK, Europe, or Ireland. There is a daily service from Heysham (Lancashire), and seasonal crossings to Liverpool, Dublin and Belfast. You can drive your car or van on board and relax as you journey to your new home.

Of course, if you are coming from farther afield, you will need to fly. Flying is the quickest and, for many, the most convenient way to get here. In recent years, the Island's air connections have expanded, leading to greater choice for travellers. The Isle of Man Airport, Ronaldsway, has regular flights to and from England, Ireland, Northern Ireland and Scotland, making it ideal for international connections.

Couriers

Vehicle Registration

All UK, Channel Island, Irish or foreign registered motor vehicles brought into the Isle of Man must be re-registered in the Island at the earliest opportunity. You can do this online by visiting

Online Services

The following documents must be submitted either Online or to the Vehicle and Driver Test Centre:

- an application form for both registration of the vehicle and its first licence
- any current registration documents
- certificate of car insurance
- under certain circumstances, you may need to present a 'road worthiness certificate'

If your vehicle is over 5 years old a roadworthiness test must be booked for it immediately at the vehicle test centre.

If you are bringing a motor vehicle from outside the UK, you will also need a Customs Clearance Certificate.

Vehicle Tax/Licence Fee

To drive a vehicle on Isle of Man public roads, your car will need to obtain a 'Vehicle Licence Fee'. To apply and pay for your vehicle tax, visit the [Isle of Man Government website](#).

Driving Licence

New residents must obtain an Isle of Man driving licence within 12 months of becoming resident in the Isle of Man.

A foreign licence can be used for up to 12 months but you will need to pass your test within that period or otherwise revert to a provisional driving licence.

In some cases, if you hold a driving licence issued outside the Isle of Man and you come to reside in the Isle of Man you may be able to take out an Isle of Man driving licence for some or all of the categories of vehicles shown on your existing licence without having to pass a driving test in the Island. Communications

Internet

While the Isle of Man may be in the middle of the Irish Sea, there have been huge investments into fibre optic technology and improved services for local customers, who benefit from 97% broadband coverage and 99% 4G coverage.

Phone Networks

Isle of Man phone numbers work in the same way as the UK with its own area codes. The Island also utilises the UK's international dial code (+44).

The Isle of Man has its own set of telecoms service providers (above) so you will need to set up a new landline number and mobile phone SIM card when you move.

Please note that the Isle of Man is designated as a roaming destination by certain UK and overseas mobile operators so anyone using their UK or overseas mobile phone will be liable for roaming charges when making a voice call or accessing data.

Assistance and Support

The Isle of Man Government's Department for Enterprise offers a number of financial grants and schemes to help start, grow and relocate your business to the Isle of Man. These include:

Government Financial Assistance Schemes

Business Consultancy Scheme - The Scheme helps businesses engage external consultants to undertake projects such as website development and marketing, with matched funding available to a maximum of £10,000.

Business Emissions Saving Scheme – The Scheme offers a grant 75% up to £5,000 towards an energy audit and 100% interest-free unsecured loans up to £100,000 offers a grant 75% up to £5,000 towards an energy audit to eligible businesses to make their operations more energy efficient, lower energy costs and reduce emissions.

Business Start-Up Scheme - The Scheme provides start-ups and early stage small businesses the necessary training, financial support and mentoring to get their business off the ground. Matched funding of up to £6,000 available for all eligible businesses, with assistance of £15,000 for exporting businesses and childcare providers. Further assistance of up to £10,000 is available to support job creation.

Employment Incentives - The Scheme provides a 25% grant of up to £10,000 towards the cost of a relocating employee's first year net salary for either off-Island workers or graduates from on or off the Island.

Financial Assistance Scheme - The Scheme is discretionary and can offer a generous package of support to qualifying businesses. This includes grants of up to 40% towards a range of capital and operating items including building works expenditure, plant and machinery, marketing, first year expenses, rent, training and efficiency measures.

Other Government Financial Assistance

The National Insurance Holiday Scheme provides refunds of up to £4,400 on Class 1 National Insurance Contributions for returning students who graduated after 6 April 2019 and secured employment within five years, subject to eligibility requirements.
