1. Nepal National Logistics Cluster storage and transport update

The following updates were shared regarding the Nepal National Logistics Cluster services:



- The National Logistics Cluster continues to provide common transport, storage and coordination services to MoHP and Provincial Health Directorates, to ensure a timely and uninterrupted flow of essential lifesaving health supplies and equipment to the health facilities across the country.
- The National Logistics Cluster this week:
 - Transported oxygen cylinders for refilling for hospitals in Biratnagar, Chitwan, Dhangadhi.
 - Dispatched 110 MT (209 cbm) medical supplies, mainly oxygen cylinders, to all seven provinces.
 - Provided support to Seti Zonal Hospital in Dhangadi district to transport full and empty oxygen cylinders.
 - Upon request from NEOC, MoHA, 50 tents and 200 tarpaulins were delivered for the households affected by the earthquake of 19 May in Lamjung district of Gandaki Province.
 - Received 2,560 oxygen cylinders (2,000 donated by the Government of China and 560 donated by the Oman government) for storage at the Humanitarian Staging Area (HSA) in Kathmandu. Received various medical items such as PPE, ventilators, oxygen concentrator, thermometer and antigen test kits donated by various donors received for storage and onwards distribution at the HSA.
- The National Logistics Cluster assessed the oxygen supply chain to see how resupply could be sped
 up. The initial finding showed that the resupply of oxygen in the country could be sped up by
 increasing the number of staff at MoHP and enhancing coordination with oxygen manufacturers.
- The National Logistics Cluster developed a Google spreadsheet with cargo flight information, to
 enable cargo consolidation of air shipments to Nepal. The spreadsheet will be updated with flight
 information regularly. Link to this online sheet: Nepal Cargo Flight information
- WFP offers upstream logistics services (by air, ocean, road) for international shipments and
 cargo consolidation at strategic hubs for cargo destined to Nepal, through its Service Market
 Place. This service is available at-cost to all humanitarian agencies in Nepal. The website clarifies
 how a transport service can be requested. Link: Service Marketplace.

2. Health Logistics Update

- The USAID-chaired External Development Partners-Supply Chain Management working group (EDP-SCM) informed that they are working closely with the Management Division of MoHP, the Global Health Supply Chain Program-Procurement and Supply Management (GHSC-PSM) project and WFP to track arrival and plan distribution and delivery of the COVID-19 supplies in the country. USAID requested all partners to update the supplies being procured for COVID-19 response on the google spreadsheet here:
 - Covid-19 Commodity mapping tracking sheet.
- UNICEF informed, early this month, they handed over syringes worth three million USD and
 155,000 pcs of antigen test kits to the Government of Nepal (GoN), brought from South Korea.
 UNICEF also donated oxygen concentrators to the regional hospitals in Janakpur and Parsa
 districts. They further informed that procurement of PPEs is under process and 800 oxygen
 cylinders are expected to arrive in Kathmandu by the first week of June. 20,000 oxygen cylinders
 requested by the GoN to UNICEF are also under procurement in China.



Care Nepal informed that Association of International NGOs in Nepal (AIN) is doing a joint
procurement of COVID-19 supplies based on the list received from the MoHP. They requested to
directly contact Care Nepal if any of the agencies are interested in the joint procurement. They
also informed that CARE Nepal has been selected by AIN as lead agency for the procurement, with
technical support from One Heart Worldwide.

3. Logistics gaps and issues

- IFRC inquired if WFP has any plan to restart the air service like last year. If yes, would it be possible for IFRC to use the air service to bring medical equipment from China? They also inquired if IFRC could use the National Logistics Cluster common services in Nepal. WFP informed that the transport and storage services were stopped at the end of February and have not resumed. Currently WFP is only providing transport and storage services to the MoHP and Provincial Health Directorates, to support with the COVID-19 response. Regarding the WFP air service: There is no plan yet to restart the air services, since the government has given approval last week for two commercial flights per week to resume (from Kathmandu to Doha and Guangzhou). Since that is expected to fulfill the immediate need of humanitarian organizations, there will be no need to resume air services. Regarding storage at the HSAs, long term storage is possible on cost recovery basis through establishing a Service Level Agreement with WFP.
- ACF inquired if there was any update on the customs waiver for medical supplies for COVID-19
 response. WFP informed that no tax will be charged on medical supplies for the COVID-19
 response and advised for these supplies, to request the Development Support Coordination
 section of MoHP to issue a letter to support customs clearance, to the Inland Revenue
 Department.
- Mountain Child inquired if the dates have been finalized for the weekly commercial flights approved by the Government and if there is any gap expected regarding cargo flights to Nepal? WFP informed that it does not yet know the dates of the weekly commercial flights and believes there won't be any gap in cargo flights due to the planned resumption of commercial flights to Doha and Guangzhou. At regional level, during the recent Global Logistics Cluster Call Southeast Asia Impact of COVID-19 on Humanitarian Logistics, the private sector has shared their perspective that regional cargo flow is stabilizing and the absence of commercial passenger flights is being compensated by cargo flights and trade is picking up. Therefore, there are no major gaps expected by the private sector at this point.

4. AOB

 WFP informed that the National Disaster Risk Reduction Authority (NDRRMA) and MoHP have issued two policy documents. The policy document issued by NDRRMA was to announce activation of all national clusters to respond to the COVID-19 crisis. MoHP requested all health partners and donors to provide support through the one-door mechanism in coordination with Health Coordination Division of MoHP, following a meeting of Incident Command team held 12 May.



• WFP informed that on 18 May 2021, the GoN announced that they will allow two commercial flights a week, one flight each from Guangzhou and Qatar through Nepal.
