Trainings:

- The WREC team will be attending the upcoming IFRC Global Supply Chain conference and an UNDP procurement training in March.
- UNHCR has expressed an interest in joining the partners' coalition of the WREC project.

<u>Annual retreat – Global Clusters Coordination Group (GCCG) – February 2024:</u>

The funding environment looks very poor for all Clusters.

- There is an ongoing IASC review and the current IASC structures remain in place until June. As a consequence of this IASC review, some restructuring of the UN architecture can be expected.
- One of the key themes of the recent GCCG retreat was the discussions on the nexus. It was noted that
 humanitarians have expanded along the continuum into the middle space, but that development actors
 have not moved to meet in the middle. The idea is to better bridge the gap between preparedness and
 capacity strengthening support and long-term technical assistance.

2. Update on the Gaza response

Discussions are ongoing in terms of the provision of support to the Senior Humanitarian and Reconstruction Coordinator for Gaza when it comes to cargo verification, reconstruction, and supporting initiatives to assist additional aid entering Gaza.

• To bring in additional aid from Jordan, the Logistics Cluster teams are assessing to which extent a relocation of activities is required.

3. SAG members' updates

Service Provision Working Group

The Letter of Intent (LoI) was signed by Atlas Logistique.

Discussions are ongoing on how to ease the understanding process of the Concept of Operations (ConOps)
 and the Gaps and Needs Assessment (GNA) for third-party service providers.

4. Medical Logistics Working Group ToR

• The Medical Logistics Working Group ToR was shared with the SAG for feedback.

The Medical Logistics Working Group is expected to be finite in time and is to be convened in response to the increase in requests for the Logistics Cluster to handle and consider the requirements of the health supply chain, and will focus on defining the scope of Logistics Cluster interventions in health supply chain.

5. Upcoming events

IFRC Global Supply Chain Conference

The IFRC Global Supply Chain Conference will be held from 4 to 7 March 2024.

The event provides an opportunity to start to build working relationships with the National Societies and to further coordinate in the field of environmental logistics.
