



# Logistics Cluster Emergency Preparedness: Building Resilient Supply Chains for Tomorrow's Crises

When disaster strikes, the speed and effectiveness of the supply chain can mean the difference between life and death. The Logistics Cluster's emergency preparedness work is dedicated to ensuring every country is ready to respond—by empowering individuals, strengthening national governments, and building sustainable logistics systems that endure. This approach puts local leadership at the heart of every response, supported by regional and global partnerships that amplify impact and foster collaboration.

## **Three Pillars of Preparedness**

## 1. Preparing Individuals

At the foundation of every successful emergency response are skilled, knowledgeable individuals. The Logistics Cluster invests in training and capacity strengthening to help local and international partners collaborate effectively in addressing complex supply chain challenges. By focusing on people, the Cluster creates a network of logistics professionals who can mobilize quickly and efficiently when emergencies strike.

# 2. Empowering National Governments

The vision is clear: national governments should lead emergency responses, coordinating both national and, when necessary, international actors to deliver assistance swiftly and effectively. The Logistics Cluster works directly with governments using a structured Institutional Capacity Strengthening (ICS) methodology. This approach puts national stakeholders at the centre, guaranteeing their leadership and decision-making from the start and securing locally owned outcomes for lasting impact.

### **How It Works:**

- Institutional Capacity Strengthening (ICS): The Cluster partners with governments to develop tailored frameworks that prioritize national leadership.
- National Logistics Working Group: Typically convened through the National Disaster Management Agency (NDMA), this is a coordination platform for logistics actors. This group also conducts a Capacity Needs Mapping to identify the national supply chain's strengths and gaps.
- National Logistics Action Plan: Informed by the Capacity Needs Mapping, this plan is agreed upon and endorsed by the working group and government, securing ongoing resources and commitment.
- **Enduring Coordination:** Government leadership ensures that convening, mapping, planning, and implementation keep the coordination platform active and ready for future emergencies.

#### 3. Ensuring Responsive Supply Chains

Beyond individuals and governments, the Logistics Cluster works at regional and global levels to harmonize and standardize logistics support structures. This ensures that when a national government requests support, international partners can respond predictably and efficiently

## **Regional and Global Collaboration:**

- Regional Bodies: The Cluster helps regional actors consolidate successful practices, supporting neighbouring
  countries to collaborate—especially in regions where disasters cross borders. Regional and sub-regional
  bodies are enhanced to take on coordination and capacity strengthening roles.
- **Global Partnerships:** International humanitarian organizations work in support of national leadership, aligning their structures and resources for an efficient, locally driven response.
- **Emergency Preparedness Team:** Located worldwide, this team connects national, regional entities and the global humanitarian community, ensuring seamless coordination and support.

## **Proven Impact: Real-World Success Stories**

The Logistics Cluster's methodology has delivered tangible results in diverse settings:

- Malawi: The National Disaster Management Organisation (NDMO) now reports directly to the office of the President, reflecting the elevated importance of logistics coordination. The Government led the emergency response during the last 4 cyclone responses without the need for activation of a Logistics Cluster; indeed, the national structure in Malawi has taken on the name and is called the National Logistics Cluster.
- Southern African Development Community: Regional engagement inspired the creation of a Humanitarian
  Operations Centre, bringing the sixteen countries of the group together at an operational level to respond to
  and overcome emergencies as they arise.
- Guatemala & Honduras: As disasters often affect both countries, collaboration is essential. A binational
  exercise at the border brought together NDMO, customs, and other government stakeholders. This landmark
  effort laid the groundwork for 2024 and 2025 workshops on facilitating cross-border humanitarian transit
  and strengthening mutual support during crises.

## **Conclusion**

Emergency preparedness is more than a checklist—it's a commitment to building systems that last, and empowering local leadership. The Logistics Cluster's approach ensures countries are ready to respond to the next emergency independently with speed, confidence, and resilience. By investing in people, supporting governments, and harmonizing global efforts, the Cluster is shaping a future where supply chains are more effective and efficient while saving more lives and ensuring communities recover faster.
